- 2. Last date of receiving of application is by 03:00 PM of 10/01/2025. Applications received beyond this time and date will not be considered as eligible application.
- 3. BRLPS bears no responsibility for delay in receipt of application.
- 4. Application Form of candidates who do not fulfil the eligibility criteria shall be rejected.
- 5. Officials retiring from the Government service on or before 31.01.2025 and fulfilling the aforesaid eligibility criteria are also eligible for the position.
- 6. Candidates must bring Photo ID, 02 (two) copies of coloured passport size photograph and 1 set of photo copy of all required certificates for fulfilment of eligibility criteria. Keep all documents in original also and produce the same at the time of registration.
- 7. It is to be noted that if a candidate has been allowed to appear in the interview, it does not imply that the candidate's eligibility has been verified.
