Executive Summary



With the decrease in the Covid case from July 2021 onwards, the project emphasized on vaccination of community members jointly with the Health Department. JEEViKA staff and cadres worked towards mobilization of community members at vaccination centers and ensuring maximum SHG members and their family members get vaccinated against Covid-19. Efforts were also made on awareness generation amongst community members on the prevention of Covid-19. The project during this quarter picked up the pace of implementation of different interventions. During this quarter, Didi-Ki-Rasoi units were scaled up by cumulatively forming 40 Didi-Ki-Rasoi till September 2021. To provide insurance coverage to SHG members under Pradhan Mantri Jeevan Jyoti Bima Yojana and Pradhan Mantri Jeevan Suraksha Yojana, an insurance drive was started and over 11 Lakh SHG members insured by September 2021.

In Institution and Capacity Building area, the project has formed over 10.30 Lakh SHGs till September 2021 and the focus was more on formation of higher-level federations, inclusion of SHGs into VO, VO into CLF, registration of CLFs and Training & Learning Centers (TLCs). During this quarter, a total of 1445 SHG, 1301 VOs and 91 CLFs were formed. By September 2021, a total of 1030084 SHGs, 66270 VOs and 1396 CLFs have been formed. To facilitate the registration process of CLFs and TLCs, training of around 400 staff was also done on registration process of CLFs and TLCs.

In Financial Inclusion, a total of 16426 SHGs got their saving accounts opened and 60129 SHG accounts were credit linked with credit linkage amount worth Rs. 1037.15 crore. Altogether, 950642 saving accounts have been opened and 1271675 number of credit linkages of SHG's with Banks have been done. Cumulative credit linkage amount was Rs. 16536.51 lakh till September 2021. A total of 1104268 SHG members got insured under PMJJBY and 1149440 under PMSBY till September 2021. The project is focusing to establish at least one Business Correspondent (BC) point in each Gram Panchayat. 844 Bank Sakhi were selected after training in this quarter. In total, 2562 Bank Sakhis are working as BC agents and made financial transaction worth Rs. 62487 Lakh in this quarter.

In farm sector, during this rabi season productivity enhancement activities in agriculture was undertaken by around 15 lakh SHG members. 807899 SHG members under took paddy cultivate through SRI, 442882 SHG members under took vegetable cultivation and 1257731

undertook kitchen garden. Besides this, SHG members also cultivated pulse, maize etc. through improved agriculture practices. To provide mechanized agricultural equipment to SHG farmers at reasonable rate, a total of 137 Custom Hiring Centers have been established in 32 districts. To provides value chain services to farmers in agriculture sector, 13 new Farmers Producer Companies were formed in 13 districts.

In non-farm sector, the focus was on scaling up of Didi-Ki-Rasoi intervention and 40 Didi-Ki-Rasoi have been established to provide catering services to inpatients in district/sub-divisional hospitals. 06 new Grameen Bazaar were also opened in this quarter to provide quality and branded grocery items to SHG member run kirana stores at reasonable rates. Altogether, 60 Grameen Bazars have been opened across 20 districts till September 2021. Project Staff of 22 districts were also trained on Grameen Bazaar SOP.

Back yard poultry intervention under IPDS has been initiated again this FY with distribution of 45 chicks to a SHG members. In this quarter, 70793 chicks were distributed to 2881 SHG members.

In Jobs theme, altogether 7198 rural youth were trained and 5257 placed under DDUGKY, RSETTI & district placement initiatives in this quarter.

Under vulnerability reduction, Food Security Fund (FSF) was provided to 591 new VOs and Health Risk Fund (HRF) to 789 VOs. In total, FSF have been provided to 47461 VOs and HRF to 51089 VOs till September 2021. The project also mobilized community members to get vaccinated against Covid -19. 9424911 SHG members have received 1st dose and 3204251 member 2nd dose of Covid vaccine till September 2021.

In Lohiya Swachh Bihar Abhiyan, 1833 community toilets were constructed to provide toilet facilities to community members in habitation where personal toilet could not construct due to unavailability of land. The project is now focusing on implementation of ODF plus activities that includes solid liquid waste management activities in rural areas.

Under SJY project, 125261 ultra-poor households have been endorsed by Village Organization. Livelihoods Investment Fund has been provided to a total 96881 ultra-poor households. Special Investment fund has been provided to 74005 households. Of the total HHs who have undertaken livelihoods activities, 69% have established micro- enterprise, 30% livestock and 0.5% agriculture.

Under Project Management, Communication theme of JEEViKA issued JEEViKA newsletter, community newsletter and SJY monthly newsletter. On the occasion of 75th Independence Day, Azaadi Ka Amrit Mahotsav was organized at CBO level. JEEViKA also participated in Independence Day Celebration at Gandhi Maidan Patna and received 2nd prize in tableau presentation. MIS theme developed and upgraded various applications like solid liquid waste management mobile application, livelihoods survey application, CLF GIS locator mobile application etc.

The project made considerable growth in various indicators during this quarter. The project would continue to achieve the project targets with firm actions in the coming quarter as well.

Institution & Capacity Building



Institutions and Capacity Building theme focused on the formation of SHGs and saturation of CLFs by inclusion of SHGs into VOs and further into CLFs using multiple strategies. Newly formed and eligible CBOs were provided basic modular training through a pool of developed resource persons. The theme also made a dedicated effort in imparting training to community leaders, community professionals and staff, who would further render required support to CBOs. For strengthening institutional governance, district and block teams focused on institutionalizing the review and grading of CBOs through the 'masik prativedan & grading' tool. Efforts were also made by the district and block teams in the preparation of documents for registration of selected Model CLFs, CLFs and TLCs.

1. Social Inclusion and CBO Formation


With the decline in corona cases, CBO meetings were regularized. During this quarter, a total of 1445 SHGs, 1301 VOs and 21 CLFs were formed. A total of 10.30 SHGs, 66270 VOs and 1296 CLFs have been formed.

2. New Institutional Structure and Governance

Registration of CLFs and TLCs

Out of the total 412 targeted CLFs for registration, documents of 303 CLFs have been prepared and submitted online for registration. By September 2021, a total of 70 CLFs and 2 TLCs (Gopalganj and Khagaria) received registration certificates. Gopalganj was 1st district to get TLC registered under BISSCOS Act 1996.TLCs Jehanabad and Supaul also submitted the documents for registration.

For ensuring proper document preparation, 41 Training Officers /Training Managers and 249 CLF Anchor Persons (AC/CC) from 27 districts were oriented/re-oriented (in 10 batches) in this quarter and provided support for online submission of registration documents of CLFs and TLCs. Cumulatively, a total of 38 IBCB officials, more than 400 field staff, and 400 community professionals (MBK/CF) have been oriented on the preparation and submission of documents for CLFs and TLCs. With regular interaction and required capacity-building initiatives, the staff and community professionals have been developed as resource persons for supporting primary cooperative societies.



Under the statutory activities, emphasis was given for changing the name of the CLF bank account as per the registered name, application for PAN, providing share certificate to the promoter members, developing and installing signage board as per the registered name and address in the certificate.

3. Institutionalized review system

Digitization of Masik Prativedan & Grading

For establishing robust governance and an effective community-based review system at CLF, all CLF Anchor Persons/ Managers and concerned IBCB officials in all districts were reviewed on the indicator of monthly updation of masik prativedan and grading application (MP&G) of CBOs. After orientation and follow-ups, almost all blocks started punching data of SHG MP-G for March 2021. Emphasis was given on digitizing MP-G and its usage for effective decision-making in 190 M-CLFs (30 CLFs in BTDP, 60 CLFs in NRLM, and 100 CLFs in NRETP). This will ensure the quality functioning of CBOs.

3. CBOs (SHGs, VOs & CLFs) training

As per the norms, CBOs are provided with basic as well as advanced training on set standard CBOs modules. It helps CBOs in establishing basic norms, best practices, strengthening meeting processes and leadership skills. The training are conducted at the village (SHGs, VOs) and cluster levels (CLFs) by trained CRPs, community professionals and block level resource pool members using flip charts. ToT is also organized for training resource pool to refresh their knowledge base, facilitation skills and use of flip chart. The CBO trainings are supported and

monitored by BPIU teams, who anchor briefing, debriefing and provide on-field support to CRPs and community professionals.

As per set the norms, Community Mobilizers, VO-Book Keepers and Community Facilitators are provided modular training by Block Level Training Resource Pool members at CLF, block and district levels.

The block staff i.e. Community Coordinators, Area Coordinators and Block Project Managers were provided basic trainings on SHG concept and management, VO concept and management, CLF concept and management, CBOs masik prativedan, grading of CBOs and CBOs process and quality at district level. These trainings would improve the knowledge base, field-level experiences, training and communication skills of community professionals and staff. Block Level Training Resource Pool has been developed to provide training to staff and cadres using standard training modules, case studies, training videos, case lets etc.

During this quarter, 307 units of residential and non-residential trainings were organized for 9321 cadres and staff. Out of the total 307 units of training organized during this quarter, 63 units of training were organized at Training & Learning Centres in which around 1902 participants were community cadres.

4. Strengthening of Model CLFs and CLFs

New CLF formation and training

With the support of senior CRPs and trained block resource pool members, a total of 91 new CLFs were formed in this quarter. A total of 1287 CLFs have been formed till September 2021. Pool of senior CRPs has been developed at resource blocks/ resource CLFs, who supported districts in the formation of new CLFs as well as training to member VOs and new governing structure of CLF (GB, RGB and BoD).

Before the formation of CLFs, (10-12), member VOs are provided training on CLF concepts. After this, first General Body meeting is conducted and committee members are oriented, RGB is constituted and training is imparted to the Representative General Body and Board of Director, selected OB members on CLF concept.

Model CLF visioning exercise

CLF, visioning exercise has been conducted in 52 M-CLFs. The CLF visioning training contains three modules viz. preparation for building member connect and need for envisioning, mapping aspirations and priorities and vision consolidation. Each module contains various interactive tools and techniques to augment the learning experience. After completion of the visioning exercise, CLFs prepared vision documents for 3-5 years.

5. Roll out of MP & MG

Orientation of district and block staff on MP&G tools, application and process of digitization of CBOs masik prativedan at MP&G application was completed in all 38 districts. Filling of new monthly masik prativedan at SHG, VO and CLF levels have been started in all the districts. Further, after orientation of block staff, digitization of CBOs masik prativedan data on MP&G App. has also been started. This application will help VOs to grade their SHGs and CLFs to grade their VOs. It will prove to be an effective community-based monitoring mechanism for CBOs.

6. Block level quality committee meeting

"Block-level CLF quality committee" meetings are being conducted to strengthen the CLFs, CBOs quality and leadership skills. During this quarter, a total of 112 block-level CLF quality committee meetings were conducted.

7. District level CLF strengthening committee

During this quarter, "District level CLF strengthening committee" meetings were conducted in 31 districts. "District level CLF strengthening committee" comprise of DPM, thematic managers, BPMs and OB members from each CLF. This is a platform to strengthen the coordination among CLFs, BPIUs and DPCU. It is also a platform for TNA of CLFs and resolve the existing issues and problems at CLF level. Along with block level agenda the meeting agenda included roll-out of MP & MG, cadre payment, procurement of infra items at Model CLFs/CMTC, repayment, TNA of CLFs, CLFs role in bank linkages, livelihood and social development activities etc. As per TNA of CLFs road map are finalized for training and capacity building of CBOs and community professionals.

8. Community spearhead team

"Community spearhead teams" have been formed in 52 M-CLFs comprising of senior CRPs, CRPs, rotated VOs and CLFs leaders. The community spearhead team provides support to concerned CLFs in improving CBOs quality, repayment, training to CBOs, monitoring and providing services to member VOs. There are 10-15 members on an average in the community spearhead team at Model CLFs.

9. Training and Learning Centres

Formation of TLC

In this quarter, 91 new TLCs were formed following predefined protocols like conducting orientation of GB, RGB and BoD members. Initially, orientation on 'TLC' was also conducted for district thematic managers and BPMs. Followed by other protocols for TLC formation like MoU between TLC and the CLFs, TLC and DPCU and account opening.

Registration of TLC

To facilitate registration process of TLCs, TLC district staff were given training on the process of registration of TLCs. Following which, in this quarter, 12 TLCs have prepared documents for TLC registration and completed online document submission. 2 TLCs namely Gopalganj and Khaqaria received registration certificates in this quarter.

• 3 days Residential training of district staff on "TLC concept & management"

3 days residential training was organised for district staff of Madhubani, Muzaffarpur, Saharsa, Jehanabad, Madhepura, Supaul, Arwal, Gopalganj, Rohtas, Bhagalpur, Katihar, Nawada, Samastipur, Sitamarhi, Motihari, Siwan, Buxar and Banka. A total of 33 participants comprising of IBCB Managers and Training Officers participated. At the end of the training, each district presented its plan of action for 3 months i.e from October to December 2021 to strengthen the functioning of TLC in their districts.



Celebration of Amrut Mahotsav

Azadi ka Amrut Mahotsav was celebrated in 14 Training & Learning Centres and 18 Community Managed Training Centres. Various activities were taken up to create awareness on the significance of celebration of Amrut Mahotsav. Best performing cadres were also felicitated with certificates. The event was organized from 20th to 25th September 2021. BPMs and TLC's RGB and BoD members participated in the event.

Audit of TLCs

Among 1st phase TLCs, 8 districts namely Madhubani, Muzaffarpur, Purnea, Khagaria, Nalanda, Supaul, Jehanabad and Rohtas have conducted Audit for FY 2019-20. Audit reports have also been sent to TLCs by the auditors.

Training in TLC

Around 400 units of training were organized at TLC on various topics in which around 11900 participants participated.

Financial Inclusion



The Financial Inclusion theme during this quarter focused to provide financial support to the community through saving account opening and credit linkage of SHGs. Cumulatively 16426 SHG saving accounts and credit linkage of 60129 SHGs were done till September 2021. The theme also focused on prompt repayment of SHGs which helped 33646 SHGs to get an Interest subvention amount of approximately Rs.2.37 crores. During this quarter, a total of 1104268 members were insured under PMJJBY and 1149440 members under PMSBY through Banks. 132 CA firms conducted CBO audit in 357 blocks. 25000 CBOs are likely to be audited for the period of FY 2019-20, out of which 22814 CBOs have been audited.

1. Achievement of bank linkages, prompt repayment and interest subvention with mainstream banking

The Bank Linkages of the Self-Help Groups moved ahead with the strengthening of the system further in terms of saving account opening and credit linkages. Continuous endeavours were made to follow with different banks, in order to ensure supply of saving and credit linkage forms for facilitating financial transactions with banks. During this quarter, a total of 16426 SHGs got their accounts opened and 60129 SHG accounts were credit linked (1st, 2nd, 3rd and 4th linkage) with credit linkage amount worth Rs. 1037.15 crore. Cumulatively till September 2021, saving

accounts of 950642 SHGs have been opened and 1271675 credit linkages of SHGs (includes 1st+2nd+3rd+4th credit linkage) have been done with different banks. Total credit linkage amount stood at 16536.51 crore. MoUs were signed with HDFC, Indian Bank and IDBI Bank during the quarter for Financial Inclusion related activities.

Prompt Repayment

To inculcate the habit of monthly repayment in SHGs and ensure following of panchsutra religiously, the SHGs were mobilised to approach respective banks under "Bank Samvaad" campaign. This motivated bankers to increase lending to SHGs in rural areas. A Help Desk team was constituted at District level and FI-nodals were selected at Block Level to support the timely repayment of loans by SHGs. An office order was also shared in this regard from SPMU. State FI theme followed with blocks, SHGs, community cadres and even SHG members, which

resulted in timely and prompt repayment by SHGs and at the end of September 2021, FI theme has been able to maintain the repayment of 97.5%.

Interest Subvention

The process for payment of interest subvention amount to eligible SHGs was completed for Saran, Siwan, Madhubani and Katihar districts for a total amount worth Rs.8.70 crore to be disbursed to 33646 SHGs.



Hand holding support was also provided to district as well as block teams for maintaining and updating the branch-wise details of SHG accounts for payment of interest subvention amount. An amount of Rs 2.38 crore was transferred to 6423 SHGs accounts in Saran district.

2. Capitalisation of CBOs with Revolving Fund and Initial Capitalisation Fund

Capitalisation of CBOs is an important indicator of the project. It is also an important aspect for sustainable development of the CBOs. Financial Inclusion team took this agenda on priority and intensively followed up with the district teams for submission of application for disbursement of Revolving Fund (RF) and Initial Capitalisation Fund (ICF). As a result of these efforts, almost 22110 SHGs were provided Revolving Fund worth Rs. 33 crore and Initial Capitalisation Fund to 5003 VOs worth Rs. 300 crore. Cumulatively, a total of Rs. 333 crore was disbursed during this quarter.

3. Micro Insurance- "Ensure to Insure"

The project is providing insurance coverage to SHG members under Pradhan Mantri Jeevan Jyoti Bima Yojana(PMJJBY) and Pradhan Mantri Suraksha Bima Yojana (PMSBY) through Banks. For enrollment of SHG members under insurance programme, awareness amongst the community members was created. SHG members were sensitized to keep adequate amount for premium deduction in their bank account. Considering the need and importance of insurance of poor and marginalized members at the bottom of pyramid, it was also decided to include members of SJY under the umbrella of social protection at project cost.

To bring community into insurance fold, detailed guidelines in form of office order was issued to prepare ground for enrolment. Meetings were done in all the districts through VC with MF/CF managers, YPs, Consultants, BPMs and FI nodal to share detailed strategy. Team were guided to maximize the insurance coverage for the community. By September 2021, a total of 1104268 SHG members got insured under PMJJBY and 1149440 members under PMSBY.

During this quarter, 49 new claim documents of PMJJBY were received at SPMU. Total 53 claim documents were submitted in LIC for settlement. Effectively, 69 claims of PMJJBY worth Rs 138 Lakh were settled during this quarter.

4. Alternate Banking- "Bank Hamare Gaon"

JEEViKA is working on project of setting up community managed Customer Service Points with a view to expand and deepen the digital payments ecosystem in rural areas.

The project is involved in identification of new Bank Sakhis, provide capacity building, certification through IIBF and ensure effective functioning of the established Bank Sakhis. Efforts are also made to strengthen the existing Bank Sakhis and ensure that bucket of services being provided through them gets enhanced in order to facilitate access of different financial services at the nearby vicinity or door step.

Collaboration with business correspondent of major banks (like DBGB, ICICI, PNB, CBI, SBI, BOI, FINO Payments Bank and IDFC First Bank, Canara Bank, Union Bank of India) namely Manipal, C-DOT, Synapse Solution Pvt. Ltd, Common Service Centers, Vedavaag Systems Ltd. and Sanjivani, has been done and operationalized. The strategy of working towards identifying suitable women SHG members to become BC agents (Bank Sakhi) is in different phases with different banks.

CSC- Digipay (Common Service Centre)

JEEViKA has started working with CSC-Digipay in all 38 districts from this quarter, with the Book Keepers / Master Book Keepers working as Digipay Sakhi. In addition to their current work, they would also provide financial services to the SHG member and help in creating digital ecosystem. This will give them an additional source of income. Total 331 SHG members and cadres have started working as Digipay Sakhi.

Dual Authentication

Dual authentication facility has been activated for CBOs. This facility enables CBOs to access their accounts from CSPs through biometric authentication of the office bearers. This facility initially has been activated for CLFs and VOs in the first phase. Dual Authentication is live with SBI, BOI, BOB, ICICI, UBI, UBGB, DBGB and CBI. The procedure has been shared with concern districts (Madhepura, Muzaffarpur and Madhubani) where Dual Authentication is active. To capture data on real time basis, a format has been designed and circulated.

JEEViKA as a Corporate Business Correspondent

• JEEViKA is in the process of giving letters to different banks like SBI, CBI, BOB, DBGB, and UBGB for establishment of JEEViKA as CBC. The letter was given to SBI.

Technical Service Agency

Two agencies are on board as Technical Support Agency. M/s BASIX Ltd has been hired through JEEViKA and M/s INDUCTUS placed by SIDBI to provide required TA (Technical Assistance) to JEEViKA's Digital Financial Service programme.

Knowledge Management

- Monthly meeting with stakeholders (FINO, IDFCF, and ICICI) was organized to increase the pace of implementation of Alternate Banking intervention.
- 3 months transaction analysis was done to monitor the performance of Bank Sakhis and steps taken for improvement wherever required. Best performers were also felicitated.
- Followed with the Bank Sakhis having zero transaction through calls and resolved issues to improve the functioning of CSPs.
- Refresher training of Bank Sakhis were conducted by different Banks and CBCs as per requirement.
- Repayment status of Bank Sakhis was tracked based on the fund support provided by the project.
- · Bank-wise data was preparate for the pending fund against the office order.
- Case Studies prepared and shared with NRLM.

5. Community Finance

Audit

Audit of around 25000 CBOs for the FY 2019-20 is being done by 132 CA firms covering 357 blocks. During this quarter, focus was on digitisation of audit report in audit software by 131 CA

firms. A total of 22581 audit reports have been submitted by the Auditors. Regular monitoring was done with CA firms and districts teams regarding timely digitisation on MIS audit module software and payment to CA Firms. Total of 108 audit firms submitted their bills to the DPCUs, out of which 75 audit firm bills were in verification process and 10 CA firms payment completed.

Capacity Building

Training and capacity building of staff and cadre is a continuous process to improve the efficiency and quality of staff and community professionals. During this quarter, the district teams were asked to plan and provide training to newly joined ACs and CCs in their districts.



The trainings would be instrumental in ensuring/ strengthening the financial discipline at CBOs level. During this quarter, 65 batches of training were completed against 77 batches planned.

· Financial Discipline & Management

An office order numbered 900 on Financial Discipline & Management was issued on 08th July 2021. The policy aims to provide detail guidelines on financial discipline at CBO Level.

Books of Record

During this quarter, the project delivered 42000 VO books of record, 1600 CLF books of record and 2 Lakh SHG books of record to various districts.



Livelihoods Promotion

A. FARMINTERVENTIONS

To promote value chain interventions, 13 new Farmers Producer Companies were formed in this quarter. The theme also focussed on productivity enhancement activities and around 17 lakh farmers undertook various agriculture enhancement activities this rabi season.

1. Productivity enhancement in crops

During this quarter, over seventeen thousand farmers undertook farming through different package of practices. The progress made during this kharif season is as mentioned below:

- A total of 1527416 households undertook various agriculture productivity enhancement activities in this Rabi season.
- 807899 farmers cultivated paddy through SRI.
- 230890 farmers undertook intercropping with maize and pulses on 79221 acres of land.
- 98428 farmers cultivated pulses on 11165 acres of land.
- 442882 farmers were involved in vegetable cultivation.
- 1147928 farmers did Kitchen-gardening.
- 10393 Village Resource Persons were trained and engaged as Farm Livelihood Resource Persons.
- 17799 Community Mobilizers were engaged in implementing Farm Livelihood interventions.
- Around 40,000 Village Organizations were associated with the intervention.

2. Custom Hiring Centres (CHCs)

Altogether 137 CHCs have been established across 32 districts in convergence with the Agriculture Department, Government of Bihar. Out of these 137 CHCs, 123 Centres have received the subsidy part from the Government of Bihar amounting to Rs. 6,33,59,953. During kharif season, a total of 33,233 farmers have been benefited from CHCs.

3. Organic Farming

Organic farming has been started in Purnea, Madhepura, Khagaria, Saharsa, Supaul, Madhubani, Muzaffarpur, Nalanda, Jamui, Gaya and Patna districts. In 41 blocks, altogether 119 Livelihoods Groups are being promoted. In this quarter, 6 new blocks were included. A total of 4493 farmers are practicing organic farming on 617.5 acres of land. For the promotion and hand holding support in Organic farming intervention, a separate cadre base is being developed as Livelihood Resource Person (LRP). Cumulatively, 55 Livelihood Resource Persons are working in panchayats and orienting farmers on the organic formulations, vermi-composting and its benefits.

Training and capacity building activities for upcoming Rabi season is being done at Block level. With the help of trained cadres, use of biofertilizers, crop rotation, green manuring and organic formulations like Jeevamrit, Nimastra, etc is being promoted amongst farmers. 2864 farmers profile have been collected on PGS India format for registration and organic farming certification purposes.



As a pilot intervention, Jeevika is promoting natural farming practices in 3 districts covering 6 blocks in total. The districts of Purnea, Gaya and Madhubani were selected from different agro-climatic zones. 2244 farmers are undertaking natural farming activities like practicing border cropping, mixed cropping, crop rotation, mulching and use of locally available resources for farming. 497 acres of land has been covered so far under natural farming intervention. Vegetable cultivation is major product under natural farming. Food grains i.e., wheat and paddy are also being produced in Madhubani and Gaya regions.

5. Farm Value Chain Interventions

During this quarter, 13 new FPOs were formed in 13 districts. The bank accounts of these 13 FPOs were also opened. Details of newly formed FPOs are as mentioned below:

Other activities done under value chain interventions in farm sector are as mentioned below:

- MoU was signed with APMAS on 1st July 2021 for the promotion of FPOs in Bihar.
- Shreshtha WFPC, Samastipur got FSSAI license to initiate the Turmeric processing unit.
- Narianant Jeevika Mahila Agro PCL, Vaishali got Dealership License from Agriculture Department, GoB.
- On 12th August 2021, Rs. 33 Lakh was distributed to 11 new FPOs as 1st trench of equity fund under 10K FPO scheme.
- Samarpan WFPC, Muzaffarpur is the 1st FPC of JEEViKA which got its IEC (Import-Export Code).
- Aranyak WFPC, Purnea also got its IEC.

6. Orientation on Pradhan Mantri Formalisation of Micro-Food Processing Enterprise (PMFME)

On 11th September 2021, State Horticulture Mission completed orientation on PMFME schemes for all District Project Managers, Manager Farm and Manager Non-Farm. It is a gateway for the establishment of food processing units at the grass-root level.

7. Participation in Export Exhibition



On 21st & 22nd September 2021, an export exhibition was organized by the Department of Commerce, Ministry of Commerce & Industry, GoI in collaboration with APEDA at Adhiveshan Bhawan, Patna. The program was part of Amrut Mahotsav. Department of Industries, GoB allocated one stall for showcasing farm-based products of JEEViKA. JEEViKA displayed farm-based products in the program. A total of 20 products were displayed in the program. This was the first time when JEEViKA products were displayed for export purposes. Minister of Industries, GoB, Shri Sahnawaz Hussein and Shri Amrit Lal Meena from GoI visited the JEEViKA stall.

B. NON-FARM INTERVENTIONS

The project has scaled up core interventions of non-farm interventions in this quarter. 27 new Didi-ki-Rasoi were opened in this quarter and 6 new Grameen Bazaar units.

1. Grameen Bazaar

Grameen Bazaar outlet is a community driven wholesale hub for providing quality and branded grocery items to shareholder kirana stores at reasonable price. Besides shareholder kirana stores, Grameen Bazaar outlets are also providing supplies to Didi-Ki-Rasoi, VOs under FSF intervention, TLCs, SJY beneficiaries shops, SVEP shops etc. During this quarter, 6 new Kirana Bazaar outlets were opened. Cumulatively, 60 Grameen Bazaar units have been opened across 20 districts. During this quarter, total sale of Rs. 4.27 crore was done by 60 Grameen Bazaars.

i. Key highlights of Grameen Bazaar intervention in this quarter:

- a) Comprehensive Standard Operating Procedure on Grameen Bazaar encompassing all implementation aspects has been rolled out via office order number 1076 dated 16th July 2021.
- b) Centralized Performance Management System / Centralized POS has been installed in 58 Grameen Bazaars.
- c) Dashboard for Grameen Bazaar was developed to view sales & purchase related data.
- d) 31 Grameen Bazaars completed PAN registration process.
- e) Help desk services was also used to connect and get feedback from store managers, OB members and Kirana members during this quarter for improvement in Grameen Bazaar services.
- f) Monthly review meeting of Store Managers was conducted to provide information on monthly schemes, product orientation by tie up companies, sales-purchase analytics, CPMS inputs and progress was review on different indicators by SPMU team.
- g) Market linkage with suppliers is critical for ensuring improved profitability and assortment. Tie-up was done with Shantinath Detergents Pvt. Ltd (SDPL) at state level. District level tie-ups for direct supply to Grameen Bazaar was done with 32 vendors in districts of Vaishali, Gaya, Darbhanga, Rohtas and Buxar.

ii. Training & Capacity Building

Training of staff Managers Non-Farm, BPMs, ACs, LHSs from 64 blocks and 22 districts on the topic of Grameen Bazaar SOP was completed in this quarter.

2. Didi- Ki- Rasoi

Till September 2021, altogether 40 DKRs have been established across the districts. It has been proposed by SC & ST Welfare Department to start DKR units in schools also. The piloting would be done in six schools (three from Patna, one each from Begusarai, Sheikhpura and Saharsa) of Bihar where food will be avail to students at cost of Rs.76 per student per day, for which MoU is yet to be signed by both parties.



3. Art And Craft - Shilpgram Mahila Producer co. Ltd.

"shop.brlps.in" is JEEViKA's online platform for selling of different products manufactured by SHG members. This online website was initiated in June 2020. A total of 525 orders have been received through online website till September 2021 for a total amount worth Rs. 572774. Products being sold through the website are - honey, different types of masks, madhubani painted sarees, folders, kettles, stoles, cushion covers, paintings of different range, sikki items, sikki paintings, Budhha statue etc. The most sold items are madhubani painted stoles and Jeevika honey. Till September 2021, a total 111 stoles have been sold worth Rs. 176979 and honey worth Rs. 66610 have been sold through the website. Order have ben received from 20 states of India. There are 125 live products available on the website.

4. Bee Keeping

During this quarter, the process for registration of Madhugram Mahila Producer Company Ltd. was started. Three staff have been posted in the company and fund worth Rs.39,63,300 has been sanctioned to the company as operational fund.



5. Non-farm activities under National Rural Economic Transformation Project

In Bihar, BRLPS is implementing NRETP- Enterprise Promotion activity in 40 Blocks spread across 12 Districts.

One Stop Facility Centre

Under the NRETP-Enterprise promotion (National Rural Economic Transformation Project), Nano enterprises (turnover of up to INR 6.00 lakhs per annum) will be supported under OSF (one stop facility centre), which are growth oriented. To support these enterprises, an amount of 10 cr. has been transferred to 40 blocks nodal CLFs (25 lakhs/block).

HR Placement

- ⇒ District Technical Experts (Enterprise Promotions) have been placed in 10 out of 12 districts placed. In 2 districts, Manager NF are in charge.
- ⇒ Block Technical Coordinator (Enterprise Promotion) have been placed in 33 out of 40 blocks.

Cadre Placement

- ⇒ 484 Business Development Service Providers selected in 40 blocks
- ⇒ OSF-MC (OSF management committee) selected in 40 blocks.

Orientation and Training of Staff

- ⇒ 4 days BDSP training cum exposure visit is to be organized by districts. An office with budget was issued for the same.
- ⇒ 9 out of 12 districts have completed the training of 308 BDSPs.
- ⇒ NRETP Standard note issued to team for orientation of VO/CLF on NRETP-Enterprise promotion through BDSPs.

Technical Support Agency for Cadre training under NRETP-OSF (Enterprise Promotion)

- ⇒ NRO-Kudumbashree, kerela was on-boarded on 24th Sep. 2021, through contract signing for NRETP cadres training.
- ⇒ A workshop cum orientation on BDSP training program was conducted for NRETP district teams by NRO-Kudumbshree, Kerela.

Incubator

NRLM has selected and recommended IIM-CIP as incubator partner for Bihar under NRETP. Progress made during the guarter is as follows:


- ⇒ ToR for incubator hiring approved from the competent authority.
- ⇒ RFP issued to selected agency by NRLM (IIM-CIP), for proposal submission.
- ⇒ Technical Negotiations completed on contract for on-boarding of IIM-CIP as incubator agency.
- ⇒ Multiple rounds of discussions done with IIM-CIP on roll-out and other aspects of Incubation program.

Cluster

- ⇒ Technical Negotiations and contract signing completed with Foundation for MSMEs for handicraft promotion under cluster promotion approach on 20th September 2021.
- ⇒ A Handicraft cluster promotion initiation workshop was organized for Madhubani and Darbhanga districts by Foundation for MSMEs Clusters (FMC).
- ⇒ Baseline survey and DPR preparation was started by the FMC in concerned two districts.

6. Food fortification Unit

The food fortification units in Bodhgaya (Gaya), Bochaha (Muzaffarpur) and Mushahari (Muzaffarpur) supplied fortified food to ICDS based on order placed by ICDS. Quarterly progress can be seen in graph below.



7. Pradhan Mantri Formalization of Micro food processing Enterprise (PMFME)

PM Formalisation of Micro food processing Enterprises Scheme (PM FME Scheme) was started by MoFPI (Ministry of food processing industries), and is being implemented through NRLM and JEEViKA in Bihar. Under this scheme, enterprises engaged in food processing can get an amount upto Rs. 40,000 as seed capital. This seed capital will be given to SHG members as a loan at an interest rate of 6% per annum. In Bihar, total of 1826 enterprises have been registered on NRLM portal and fund for 1158 enterprises have received from MoFPI through State nodal agency i.e State Horticulture Mission.

8. Start-up Village Entrepreneurship Program (SVEP)

- Targets for the quarter was to establish 867 enterprises and achievement against target was 593 enterprises i.e. 68 % achievement in the quarter.
- All 593 enterprises established during the quarter were individual enterprises.
- The 593 new enterprises belonged to three different categories ie. trading: 204, manufacturing: 59, and service: 330.
- Orientation of district level personnels (NRETP) on SVEP was done in 6 batches.
- Orientation of block level staff (NRETP) on SVEP was done for SVEP-Block staff in 12 batches.
- CRP-EP training was conducted in 6 SVEP blocks (phase 2) to scale up the project. Total 40 CRP-EPs were trained to support enterprising activities.
- One intern from TISS was deployed in the SVEP block, in total 3 (other 2 interns were from DMI and Central University of South Bihar) interns complete their internship from 3 SVEP blocks

C. LIVESTOCK

Livestock rearing is an important source of income generation for poor and landless households. The project is implementing various interventions in the sectors of dairy, goat rearing and poultry to enhance income of the households through enhanced productivity, veterinary services and market linkage facilities.

1. Goat rearing

Goat rearing has emerged as source of employment and income generation for small, marginal and landless farmers, particularly SC/ST households. JEEViKA is implementing different interventions under goat rearing.

i. Pashu Sakhi Model

Under this model, Pashu Sakhi, an SHG member having experience in goat rearing is further trained on goat rearing practices and provides services to SHG members in goat rearing. The Pashu Sakih supports SHG members in the procurement of goats, training of SHG members on feed management (by the installation of goat feeder, enhance nutrition by the inclusion of azolla in their diet, preparation and consumption of dana mishran, proper feeding practices) and construction of low-cost houses for goats.



These Pashu Sakhis also provide veterinary services for immunization/vaccination against diseases, castration, insemination, deworming etc. Pashu Sakhi also provides marketing facility by organizing goat haats and better price realization during the sale of goats.

The project, till September 2021, has developed around 2399 Pashu Sakhis who provided services to SHG households.

ii. Integrated goat and sheep development scheme

JEEViKA in convergence with the Department of Animal and Fish Resource Development is implementing Integrated Goat and Sheep Development Scheme (IGSDS) in 13 districts (Araria, Bhojpur, East Champaran, Gaya, Katihar, Nalanda, Nawada, Jamui, Rohtas, Gopalganj, Patna, Purnea and West Champaran).

In this intervention, SHG members are facilitated to purchase 3 breedable Bengal bucks and get veterinary services in the form of vaccines for disease like PPR, FMD and HSBQ through the support from animal health camps/government veterinary doctors. Pashu Sakhi also provides goat rearing services as provided in Pashu Sakhi Model. This project has been implemented by JEEViKA in 4 phases and cumulative achievement is given in table below.

iii. Value chain development in Goat rearing

JEEViKA has established Seemanchal Jeevika Goat Producer Company comprising of districts of Purnea, Araria, Katihar and Kishanganj covering 22 blocks. A total of 4388 goat rearers are member of the Goat Producer Company from 190 villages of 10 blocks.

iv. Goat marketing by CBOs (local goat haats)

Goat Haats are organized to provide goat rearers an opportunity to sell livestock on appropriate rate and earn profit. Goats in the general market are sold on basis of approximate weight or on basis of the count which usually results in a loss for sellers. In these Goat Haats, goats are sold based on the actual weight for better price realization. It is also ensured that such goat Haats are organized during festive seasons when demand for goat is high in the market.

2. Dairy Interventions

i. Dairy Cooperative Society

JEEViKA in convergence with COMFED has formed around 500 Dairy Cooperative Societies (DCSs) to provide SHG members with the facility to sell milk by pouring at collection points and also receive provisions of dairy productivity enhancement services at the doorstep by COMFED.

ii. Kaushikee Mahila Milk Producer Company

JEEViKA established Kaushikee Mahila Milk Producer Company with support from the National Dairy Development Board (NDDB) for providing milk pouring facility to SHG members in the districts of Saharsah, Supaul and Madhepura. A total of 31444 members have been enrolled in 668 milk pouring points. Thirteen (13) Bulk Milk Chilling Units (BMCUs) have also been established and the producer company receives approximately 31447 liters of milk every day.

3. Fisheries Intervention

Government of Bihar made an announcement that ponds identified under Jal-Jeevan-Hariyali Abhiyaan would be maintained by SHG members. The SHG members would take up fishery activities in these ponds. Process of identification and takeover of ponds is in different stages in the districts. As a pilot, Araria district has started Integrated Fishery activity.

4. Poultry intervention

i. Backyard Poultry intervention

The Backyard Poultry intervention under Integrated Poultry Development scheme (IPDS) is being implemented by JEEViKA in FY 2021-22. Under this scheme, 45 chicks would be distribution to each of the selected household in two batches. Initially, the day old chicks would be reared at Poultry Mother Unit (Poultry Farm) for 28 days and then distribution to households with required feed and vaccination. Different vaccines are provided to chicks at Mother Unit. This includes Ranikhet vaccine on 7th day, Lasota on the 14th day and Gambro on the 21st day at Mother Unit.

ii. Partner in poultry intervention

Aga Khan Foundation (AKF) is working in partnership with JEEViKA to build capacity of Pashu Sakhis by providing them classroom and field level trainings on goat rearing practices and management. The agency also provides handhold support for implementation of Pashu Sakhi Model at the field level. Cumulatively, the agency has developed around 251 Pashu Sakhis supporting 51805 HHs associated with 440 Goat PGs. This intervention is being implemented in Bochaha, Mushahri, Sakra, Muraul, Motipur, Meenapur and Paroo blocks of Muzaffarpur district under Mesha Project.

During this quarter, a ToT was organized in which 30 staff were trained. They would work as nodal trainers. Cumulatively, 85 persons (staff/cadre) have been trained as Nodal Trainer. Refresher training was organized for 23 participants as Nodal Trainers.

Skill Training and Placement

With lessening of Covid-19 cases, the training institutes resumed its training programme for youths. Around 2040 candidates were trained under DDUGKY and 5158 through RSETIs during this quarter.

1. Deen Dayal Upadhayaya Grameen Kaushalya Yojana

I. Training and placement under DDUGKY

During this quarter, total of 79 DDU-GKY training centres of 59 Project Implementation Agencies (PIAs) were engaged in providing skill training and placement facilities to rural youths. During this quarter, 2040 candidates were trained and 1550 were placed. Cumulatively till September 2021, a total of 58027 candidates have received skill training from PIAs in different trades and 38468 candidates got appointment in different organizations.

Mobilization Camps/ Drives

JEEViKA with support of District teams and project partners has organized a series of

activities/events to celebrate "India 75th Bharat Ka Amrut Mahotsav". Under this progrtame mobilization camps/drives were organized in different blocks & districts from 13th -19th August 2021. In total, 289 mobilization camps were organised.

Hunarbaaz Award Ceremony

On the occasion of "Azadi ka Amrut Mahotsav, to recognize the efforts and achievement of specially-abled candidates who have been trained/placed under DDU-GKY & trained/self employed under RSETI were awarded. Mementoes, badges and certificate were distributed to candidates on the occasion of 'Antyodaya diwas' organised on 25th September 2021. It was a virtual event that was hosted by NIRDPR.

Deepak Kumar from DDU-GKY training centre & Shabnam Praveen from RSETI Gaya were awarded with Hunarbaaz Award.



2. Job fairs and Direct Placement

The job fair provides an excellent opportunity to the rural youths to explore employment opportunities. Direct placement is a platform for the youth to meet several employers at one place.



In this regard, virtual meetings were organized with different employers like HCL Tech-Bee Program, E COM Express, RODAMINE (RTD Global HR PVT LTD, Reliance Smart Store, G4S Security, SIS Security, Nav Bharat Fertilizer, Cogent pvt. Ltd, NTTF, Minda Industries Ltd, Gram Tarang, Foxlink, Rising Star Mobile India Ltd and Fun first private limited.

3. Rural Self-Employment Training Institutes (RSETIs)

Rural Self-Employment Training Institutes (RSETIs) are dedicated institutions set up across all the districts of Bihar for skill upgradation and skill training of the rural youths. JEEViKA with the support of MoRD, the Government of India and the lead banks is closely working with district units of RSETIs to provide self-employment training to rural youths in almost 61 approved trades. After the completion of training, the rural youths are also extended support in loan to initiate a livelihood activity.

Social Development

1. Food Security Fund

Food Security intervention mandates to ensure nutritional food security of SHG households. The VOs focussed on the procurement of nutritional food items like pulses, gram, oil, soya-bean besides grain. During this quarter, around 591 new VOs received Food Security Fund. Cumulatively, a total of 47461 VOs have received Food Security Fund till September 2021. In this quarter, nearly 2700 VOs did procurement of nutritional food items including grain to support the community.



2. Health Risk Fund

Health Risk Fund is given to VOs to support the community members meet their health-related expenses. During pandemic and lockdown, to meet health-related expenses, this intervention was very supportive to provide immediate relief through fund availability to community members. During this quarter, around 789 VOs received HRF. In total, 51089 VOs have received HRF till September 2021.

3. Solar Project



In the solar project, a solar company called "JEEViKA Women Initiative Renewable Energy and Solution (J-WiRES) Private Limited is working on assembly, production, distribution, sales & marketing, partnership management & customized installation services of solar and electrical products. During this quarter, the company assembled and produced 2000 controllers and 6000 pieces of 3 Watt LED DC Bulbs in partnership with TERI. The company has traded the sales and installation of 1000 Integrated Domestic Energy Systems (IDES) in the districts of

West Champaran, Gaya, Purnea, and Aurangabad districts. The company under the brand "J-WIRES" has assembled and sold 1100 units of solar lamps and torches. Till the 2nd quarter of the financial year 2021-22, the company has made the turnover of INR 80 lakh.

In partnership with OXFAM India, the company has assembled and provided 1400 solar lamps and installed 60 units of solar street light in blocks of Sitamarhi and Nalanda districts.

4. Jal Jeevan Hariyali

Under Jal-Jivan-Hariyali Abhiyan, a program called 'Mission 5 crore' has been started by the Government of Bihar which aims at planting 5 crore trees this Financial Year. In line with this scheme, JEEViKA has also started Harit-Jeevika-Harit- Bihar Mission 1.5 and aims at planting 1.5 crore saplings this FY with a focus to conserve the environment and improve the nutritional intake of the household.



For handling, management, transparency and accountability of "Harit Jeevika, Harit Bihar," JEEViKA with the Department of Forest, Environment, and Climate Change, Government of Bihar, has developed an application known as Van Mitra App. Through this app, JEEViKA developed a micro plan at the panchayat level VO-wise and drop point manager-wise respectively. This micro plan consists of the demand for over 1.64 Crore saplings of fruit-bearing plants, wooden plants, and others.

As per the demand, the Department of Forest, Environment, and Climate Change, Government of Bihar provided a total of 9778749 saplings of different varieties of trees. In total 7353515 entries of Aadhar number of community members have been marked on the Van Mitra App. on the distribution of saplings. The entry of Aadhar number of the remaining community members was in process.

5. Didi ki Paudhsala

In convergence with the Department of Forest, Environment, and Climate Change, Government of Bihar, a total of 245 didis undertook the development of nurseries under Didi ki Paudhsala program. The list of these didis have been shared with the Department of Forest, Environment, and Climate Change, and work for the establishment of another 245 nurseries is in progress. One-day orientation of didis involved in raising the nursery was organized by the Department of Forest, Environment, and Climate Change on nursery management. Didis/SHG members from 200 nurseries have so far participated in this one-day orientation program.

6. Disaster Management

In collaboration with Bihar State Disaster Management Authority (BSDMA), training on Diaster Management and risk mitigation were organized for master resource persons from Araria, Purnea, Madhepura, Madhubani, Sitamarhi, Sheohar, Muzaffarpur, Darbhanga, East Champaran, West Champaran, Gopalganj and Siwan districts. These master resources persons have further given training to members of 77 CLFs.

In collaboration with Fire Safety Department, GoB, a one-day orientation on fire safety measures was organized for CBO members and caders. Members from 6 CLFs, 97 VOs and 180 SHGs received this training.

7. Pradhan Mantri Awas Yojna (PMAY)

In Collaboration with Pradhan Mantri Awas Yojana State team, a one-day orientation was organized on details of PMAY focusing on beneficiary selection, geo tagging, inspection



through PMAY-APP, PMAY-convergence with MGNREGA and SBM(G). In total CBO members from 334 CLFs of 21 districts have been oriented.

8. Inclusion of Persons with Disabilities

Formation of SHG

JEEViKA is committed to creating a pathway for the development of people with disabilities as part of its overall agenda of alleviating poverty in Bihar. Resources of JEEViKA would be utilized towards holistic empowerment, rehabilitation, and social inclusion of persons with disabilities in rural communities of Bihar.

Over 10,000 SHGs of people with disability have been formed. For capital generation and to enhance livelihoods, 15 SHGs with PwD are being facilitated for financial inclusion from banks.

Sightsaver

With Sightsavers, JEEViKA organized virtual meetings for orientation of BPIU teams, Community Mobilizers (CM), Book Keepers (BK), Bank Mitras (BM), Cluster Facilitators on Policy Guideline for implementation of activities with Differently Abled Persons in Gaya. UDID cards have been given to 52 PwD people, PwD certificates to 31 persons and 33 PwD persons have received training on candle making through RSETIs. In total, 580 PwD persons have been vaccinated for COVID-19 in Gaya District. Assessment camp was held at Manpur block, Gaya.

Shabnam Praveen, a JEEViKA SHG member received the "Best Hunarbaz Award" from Bihar by NIRDPR. She received this award for her creativity in candle-making and adopting this for her livelihood.

9. PRI CBO Convergence

As per the direction and support of NRLM and Kudumbshree, JEEViKA is working to prepare the Village Poverty Reduction Plan to ensure entitlement and convergence through PRIs.

Health, Nutrition & Sanitation



Health, Nutrition and Sanitation theme addresses the issue of malnutrition by the implementation of a series of interventions to encourage individuals to take up long-term sustainable practices related to dietary diversity, care and health practices.

1. POSHAN Maah, 2021

Poshan Champaign – a mass movement with people participation Poshan Maah has now become an annual event, organized every year in September. This year, four thematic areas were identified to be worked upon in September with different dates for each theme.

- From 01st 5th September 2021, Nutrition workshops & seminars were organized at district and block levels.
- In the second week from 06th -12th September 2021, JEEViKA didis and their family members were made aware of the covid-19 appropriate behavior and covid-19 vaccination by using audio & video clips. JEEViKA didis in the SHG, VO, and CLF meetings took an oath to follow covid-19 appropriate behavior.
- In the third week, which was from 13th -19th September 2021, the importance of the Nutrition Garden was discussed in the CBO meetings. The informative audio and video clips were sent to community professionals who ensured that clips are seen/heard in the meetings. The informative message contained information about –the importance of a nutrition garden, establishment of nutrition garden, fruits, vegetables and plan according to the weather conditions.
- In the fourth and last week, which was from 20th -30th September 2021, the focus was on family diet diversity and video clips on the subject were shown to SHG members by

community mobilizers. The objective of highlighting family diet diversity was to sensitize JEEViKA didi about the dietary requirements of their children and other family members.

Apart from this, poshan rallies were organized in all 38 districts. District teams organized prabhat pheri, rangoli competition and the oath-taking



celebration for JEEViKA Didis. A quiz was organized for District Project Managers, Thematic Managers, Block Project Managers, and Master Resource Person-HNS to enhance their knowledge and interest in activities related to poshan maah. A mobile application called Digishala was developed to check the knowledge of JEEViKA didis on health & nutrition aspects. Community professionals assisted JEEViKA didis in using Digishala app. This app. consists of questions on health & nutrition, which have been mostly discussed with JEEViKA didis through module roll-out. JEEViKA didis were required to answer these questions on Digishala app. to assess the knowledge absorption and retention levels of the SHG members after the campaign.

3. COVID-19 responses by Health and Nutrition

Module Development for vaccination and masking with the support of Centre for Social and Behaviour Change (CSBC)

To facilitate the process of vaccination of community members against Covid 19 and normalizing mask-wearing practices, JEEViKA with the support of the Centre for Social and Behaviour Change (CSBC) designed and developed a module related to vaccination and masking. These modules have been developed using three approaches i.e., rational approach, emotional approach for vaccine uptake and approach for mask-wearing. In rational approach, one fourteen pages flip chart and one four pages leaflet have been designed and developed. In the Emotional approach, four minutes video has been produced. Staff and Cadres training were started in this quarter on a rational and emotional approach using modules, flip charts and videos.

Covid 19 vaccination

The CBOs, MRPs-HN and CNRPs in convergence with the Health Department are playing an important role in the vaccination of SHG members and their family members.



The cadres have been actively involved in the mobilization of the community members at vaccination centers and ensuring vaccination.

4. Telemedicine

Telemedicine units at CBO level

JEEViKA with the support of EVOLKO Health Solution and Samridhi Foundation provided a health kit comprising of the thermal scanner, BP machine, oximeter, weighing scale, glucometer, and printer to districts of Begusarai, Bhagalpur, Jehanabad, Samastipur and Sitamarhi.

The telemedicine units have been established in 107 Gram Panchayats in these 5 districts at CLF level. These health care facilities are useful in the early detection, treatment and care of community members. In the COVID-19 pandemic situation, this initiative played an enabling

role, particularly reaching unreachable areas and providing patients effective treatment and care at low cost. Patients are being medically treated with the help of CNRPs, ESHAR software and doctors. CNRPs do a vital check-up of patients and enter symptoms in ESHAR application. Doctors communicate with the patient through video call and based on the symptoms and brief check-ups provides medical prescriptions to patients. Till September 2021, a total of 2377 patients have been given medical treatment.

5. Swabhimaan

Swabhimaan project works to improve health status of adolescent girls, pregnant women, lactating mothers and mothers of children below two years of age in Kasba and Jalalghar blocks of Purnea district. The work done under this project during the quarter includes following:





- Biannual review meetings were done by Swabhimaan Supervisors at VO level to discuss agendas identified in previous meetings and also new problems faced by the community during the pandemic situation.
- The health sub-committee and Kishori Shakis created awareness amongst the targeted groups (adolescent, pregnant, lactating, newly-wed) to get all the assured benefits from VHSND in intervention and scale-up areas. Apart from the regular PLA meetings, special meetings were organized to create awareness on the covid appropriate behavior amongst the target group.
- Two days of training of all Poshan Sakhi's and Supervisors was conducted in Kasba and Jalalgarh blocks. This training gave an overall understanding of the nutritional care of children under 2 years of age, the importance of growth monitoring and linking with the services.
- Considering the pandemic situation, a total of 157 field visit kits were provided to Poshan Sakhis and Supervisors. This kit included a bag, an umbrella, water bottle, sanitiser, soap, face mask, sanitary pad, diary, pen, lunch box etc.
- In every VO food demonstration by Poshan Sakhi was done.
- During this quarter, awareness was created on Covid-19 aspects amongst the community members.
- Altogether, 145 nutritional gardens were developed for the at-risk category girls and they
 were distributed with seed kits for the garden. The seeds included green and leafy
 vegetables of different varieties of spinach.

Lohiya Swachh Bihar Abhiyan



Lohiya Swachh Bihar Abhiyan (LSBA) comprises the centrally sponsored SBM-(G) and state-sponsored Lohiya Swachhta Yojana for ensuring universal sanitation coverage in Bihar. LSY is a fully State-funded initiative that intends to cover households not factored under SBM-(G).

1. ODF-S activities

After achieving ODF status in Bihar, the theme is working on ODF-S (sustainability) activities. Solid and Liquid Resource Management (SLRM) is one of the key components that can help to attain an improved quality of life in rural areas of Bihar. To maintain the ODF status of the villages and the Panchayats, the State Government is ensuring regular toilet usage, safe hygiene practices and cleanliness at the household level by effective operation and maintenance of WASH assets at households, institutions and community levels for continued functionality and usage.

The theme is also focusing on other ODF Plus interventions like wastewater management, menstrual hygiene, constantly emphasizing sustained behavior change practices, etc. Districts, depending upon their capacities and community response, are taking up ODF-S activities in their districts.

2. Capacity Building

After sustaining the noticeable progress under SBM-G towards ODF S & ODF Plus, Capacity Building becomes particularly important for District teams who are working on SLWM. There was a need to undergo training (virtual) on DPR/ Action plan-making on solid waste and liquid waste management in rural areas.



CSEDI (Centre for Sustainable Environment & Development Initiatives) extended technical support for training of district teams and covered topics like overall introduction to SLWM, sources and elements, principles and approaches to SLWM, and developing DPR (Processes, approaches for planning & DPR making, contents, formats).

3. Community Toilet

In villages/GPs where there is non-availability of land in families/households, especially in

Mahadalit Tolas/poor families, community toilets can cover the sanitation needs. LSBA has already prepared a model with a specification to construct two community toilets in each GP so that districts can construct community toilets in all such habitations where availability of land is an issue. During this quarter, 1833 Community Sanitary Complex (CSC) were constructed across the project area. tated the construction of such toilets.

4. IEC Activities

Approval of Phase-II of Lohiya Swachh Bihar Abhiyan by the State Cabinet

On 22nd September 2021, the state cabinet approved the Phase-II of the Lohiya Swachh Bihar Abhiyan. Sustainability of ODF status and management of solid and liquid waste is the key thrust areas under this phase.

To attain the objective of **Swachh Gaon-Samriddha Gaon** under the ambit of **Saat Nishchay-2**, the following components have been earmarked under the Phase-II of Lohiya Swachh Bihar Abhiyan:

- (a) Solid and Liquid Waste Management
- (b) Operation and maintenance of the previous Nishchay *(Shauchalaya Nirman-Ghar Ka Samman)*

'Swachh Gaon-Hamara Gaurav' BCC campaign

The week-long monthly behavior change campaign 'Swachh Gaon-Hamara Gaurav' aimed at sustaining the ODF status was halted in July due to Covid and in September due to the model code of conduct in the wake of the Panchayati Raj elections. Key achievements of this campaign during the guarter are as follows:


- Swachhagrahis triggered approximately 15 Lakh persons between September 2020 to September 2021 under the campaign.
- Nigrani Samitis were re-activated for monitoring the ODF status in the villages.
- Massive awareness generation resulted in a jump in IHHL construction, Geo-tagging and payments.
- Sustaining the ODF behavior of the communities.


Communities were mobilized on ODF through creative engagement by 'Swachhta Samwad', 'Ratri/Evening Chaupal' etc.



5. ODF Plus: Solid Liquid Waste Management activities

Lohiya Swacch Bihar Abhiyan has initiated interventions for supporting the districts/blocks in the planning and implementation of solid and liquid waste management (SLWM) activities.

Continuing with the ODF+ activities initiated in the first quarter, LSBA provided virtual trainings to all Sanitation Supervisors, Block Coordinators & District Coordinators on Sanitation and implementation of SLWM project at Gram Panchayat.

Other activities that have been completed in the 2nd Quarter of FY 2021-22 are as follows:

- Orientation to District Water & Sanitation team on ODF Plus activities
- LSBA phase 2 cabinet notes got approved by the Hon'ble Cabinet, Govt of Bihar
- Prepared the SLWM guideline as per the SBM-G phase-2 implementation norms
- The Training Manual of ODF Plus was finalized for the training of District, Block and GP team members
- Plastic Waste Management Campaign was conducted in all 36 Gram Panchayats, Community was made aware of 4Rs for plastic waste management.
- 2nd Instalment for the SLWM activities is processed for the 36 GP where work started in 2020.

Satat Jeevikoparjan Yojana

JEEViKA is implementing Satat Jeevikoparjan Yojana, an ambitious project for the upliftment of ultra-poor households through sustainable livelihood interventions, micro-interventions and collective action of SHGs/VOs.

1. Identification of Ultra-Poor HHs

The SJY project focuses on the upliftment of ultra-poor households traditionally engaged in Toddy tapping/ country liquor sales and households that lost their source of income after prohibition in Bihar. In total till September 2021, altogether 1,25,261 ultra-poor households have been endorsed spread across 460 blocks.



2. Promotion of Livelihood Cluster for area-specific non-farm products

A scoping study was done in 12 districts, by 'Livelihood coordinators' placed in the 12 districts. 20 such livelihood clusters were identified and their business plans prepared. Livelihood Cluster Profiles were also prepared. "Common Facilitation Centre" and producer groups in the clusters have been set up to institutionalize the production and sales. Capacity building of the Ultra-poor households belonging to the livelihood clusters has been done. Technological up-gradation and dissemination of the technical knowledge were also done through these trainings. Further, a strategy for Market linkages of the cluster products is being planned. Details of the non-fram clusters identified are as follows:

Broom Cluster (Rohtas Sadar, Rohtas)

Savarni Jeevika Mahila Utpadak Samooh, has been formed which produced a total of 1204 brooms and generated a revenue of Rs. 29400 (Wholesale Rate- Rs.19/month. Retails rate 25-30).

Bangle Cluster (Nokha, Rohtas)

A 15 days training was organized for 25 UP-HHs involved in bangle making.

Dairy Cluster (Pirpainti, Bhagalpur)

COMFED has agreed to open a milk collection center (MCC) at the dairy cluster. Procurement of the cattles (Cow and Buffalo) by beneficiaries was started.







• Bamboo Cluster (Dharhara, Munger)

Second-round of training on bamboo was completed at the cluster level. Machineries were procured for Common Facilitation Centre (CFC). CFC was established at community hall (Temporary.) Hand over of the MNREGA Building to bamboo PG was in process. Orders were mobilized (Rs.74,400) from individuals and institutions. Production would start shortly.

• Bamboo Cluster (Madhepura)

Bamboo cluster was identified and mobilization of the members was completed.

Aadikala Painting Cluster (Madhepura)

SIF was transferred for this cluster.

Paper plates (Kalyanpur, Samastipur)

22 households have been mobilized for making paper plates in the cluster approach. A market survey was also done, business plan has been prepared and submitted for approval.

3. Training of UPHHs on Confidence Building & Enterprise Development

Under Satat Jeevikoparjan Yojana, it requires an intensive approach and engagement with each household. Generally, two types of trainings are provided to targeted ultra-poor HHs one to build confidence and another on enterprise skill.

Training of identified HHs on Confidence Building

The confidence-building (CB) training is being provided by Master Resource Persons during the HH visit and group meeting before micro-planning. The confidence-building training is essential to encourage and motivate UPHHs in the selection of feasible livelihood generating activities to come out of the poverty trap.

· Training of identified HHs on Confidence Building and Enterprise Development

Confidence building and enterprise development (CBED) training is another training provided to motivate and promote ultra-poor households to establish an enterprise and provide basic enterprise development & risk management skills. To complete the training of the target household under SJY, a total number of 460 ACs/CCs/LHSs have already been identified from different districts and developed as resource pool members to conduct CB&ED training at District /Block levels. A total of 1894 Community Resource Persons (CRPs) have been identified as a dedicated pool to provide 3 days of non-residential training to the UPHHs. For easy delivery of CBED training to ultra-poor households, the CRPs are provided with flip charts on confidence building and enterprise development for a better understanding of UPHHs through pictorial representation.


4. Livelihood Financing Status

Special Investment Fund (SIF)

The special investment fund fulfills the initial capitalization requirement and basic requirements of the ultra-poor HHs. The special investment fund is a one-time grant of Rs. 10,000 which is transferred to endorse household account by the village organization through cheque. Special Investment Fund was provided to 1682 HHs in this quarter and cumulatively till Sepetmebr 2021, a total of 74,005 households received SIF.

Livelihood Investment Fund (LIF)

The project provides Livelihood Investment Fund amounting to Rs. 60,000 to 1 lakh in 3-4 tranches to the targeted households for asset creation. The Master Resource Person completes the participatory livelihoods micro-planning process of endorsed ultra-poor households, based on the micro-plans VO approved for each beneficiary, procurement committee along with MRP and the ultra-poor household procures the asset through the community procurement process.



Livelihood Gap Assistance Fund (LGAF)

The livelihood gap assistance fund is the consumption support fund that is provided to each endorsed household to fulfill the consumption-need of the household until the alternate livelihood selected by them starts earning profit. MRPs help the household in opening of savings bank account and transfer the Livelihood Gap Assistance Fund by VO through cheque to respective households. Under Livelihood Financing component of SJY, VO will provide gap assistance fund for an initial period of 7 months (Rs. 1000 per month).

5. Capacity Building of MRPs under SJY

To provide continuous support to the households, Master Resource Persons (MRPs) have been deployed for every 30-35 households. The MRPs provide handhold support to ultra-poor households in transfer of the productive assets and ensure last-mile delivery of different components of the program.

In this quarter, 173 new Master Resource Persons were selected and by September 2021 altogether 3427 MRPs across 460 blocks have been formed.

6. Capacity Building of Staffs under SJY

In this quarter, ToT was done for 390 District and Block SJY Resource pool on Confidence building and Enterprise Development in 19 batches. Orientations of all District Nodals, BRPs, ACs and MRPs have been completed virtually by the State SJY MIS Team.



7. MIS

New Monthly Progress Form for tracking of the Graduation as well as Additional Indicators through Field Reporter Pro App was finalized which is equipped with different graphical and analytical tools to support decision-making purposes.

• User Acceptance test Orientation and Roll out of Monthly Progress Form for tracking of the Graduation as well as Additional Indicators through Field Reporter Pro App.

After finalization, the new Monthly Progress form in Field Reporter Pro App was tested in Rohtas district through MRP login, Nodal Login and State Login at different locations. After incorporation of the feedback collected during the user acceptance test, the Monthly Progress Form was assigned to all MRPs, BRPs, DRPs and Resource AC's login. About 31,500 HHs monthly progress report has been captured by MRPs and 300 Monthly Progress form verified by BRPs through Field Reporter Pro App.

Orientation to Nodal ACs on SJY MIS

After the new guidelines have been issued for payment of the monthly honorarium of MRPs, based on MRP Visit captured through Field Reporter Pro App. All the Nodal ACs have been oriented on SJY MIS to support MRPs during the rollout of MIS.

Roll out of Feedback Module of MRPs through Field Reporter Pro App

DRPs and BRPs captured the feedback of HHs regarding satisfaction level on MRP services, current assets, training and this was displayed on the Dashboard.

Updation and Sync of SJY MIS and CBO MIS Database

For proper mapping of endorsed HHs with CBOs, a database of SJY MIS has been updated and about 1630 new VOs have been added.

Development of new Dashboard

For the speedy decision-making process, new interactive Dashboard has been developed with different analytical tools.

Resource Cell

1. Finalization of FNHW standard operating procedure (SOP) to support other SRLMs

JEEViKA has been designated as National Resource Organization (NRO) by NRLM, for providing support in the implementation of Food, Nutrition, Health and Wash (FNHW) interventions to other SRLMs. As NRO, JEEViKA is working with SRLMs Meghalaya, Mizoram, Manipur, Uttarakhand, Sikkim and Arunachal Pradesh. For rolling out of the FNHW interventions, JEEViKA is supporting other SRLMs in preparing FNHW-SOP. By September 2021, FNHW-SOP has been finalized for SRLMs Sikkim, Meghalaya, Manipur, Mizoram, Uttrakhand and Himachal Pradesh.

2. FNHW SOP Orientation



JEEViKA after the finalization of SOP, conducted orientation for SRLMs on FNHW SOP through a virtual platform. Uttarakhand, Mizoram, Manipur, Meghalaya and Sikkim are the SRLMs where FNHW SOP orientation has been successfully conducted. Further, three months action plan was developed for these SRLMs.

3. FNHW Module Roll Out

After successful orientation on FNHW SOP, JEEViKA has planned to roll out the first three modules developed for FNHW intervention through strategic planning by conducting Training of Trainers (ToT). The 1st three modules developed by JEEViKA include:

- · Module 1- First 1000 days of Life, part I
- Module 2- First 1000 days of Life, part II
- Module 3- Family diet diversity

JEEViKA has successfully conducted the ToT of 1st three FNHW modules for SRLM Manipur, Mizoram, Sikkim and Meghalaya through virtual mode.

4. Printing of FNHW Modules

JEEViKA has finalized the 1st three modules on FNHW taking into consideration the NRLM guidelines and developed a Flip Chart on the same. JEEViKA has also placed an order for the printing of modules in Hindi as well as English.

5. FNHW External CRPs training (ToT)

As per protocol, FNHW E-CRPs have been identified and one batch of 17 E-CRPs training was conducted from 24.8.21 to 28.8.21 in the Nalanda district, followed by field immersion. The training was provided by two state resource persons. These E-CRPs would be deployed in SRLMs as per MoUs.

6. Empanelment of SRP, DRP and state consultants

JEEViKA initiated the process for selection and hiring of the State Resource Persons, District Resource Persons and state consultants as per the requirement of FNHW intervention. These resource persons will be developed for imparting training or providing need-based support to other SRLMs. In total 16 SRPs and DRPs have been selected by JEEViKA based on their relevant experience and knowledge, whereas 2 State consultants have also been hired and designated as State consultant Capacity Building (CB) and State consultant Technical Expert (TE).

Project Management

A. Knowledge Management and Communication

Knowledge Management and Communication theme during this quarter issued JEEViKA newsletter, community newsletter and SJY monthly newsletter. The theme facilitated the orientation and the joining of newly joined Young Professionals. JEEViKA also participated in the Independence Day celebration at Gandhi Maidan and bagged second prize in tableau presentation. Campaigns like Vaccination Mahaabhiyan, Azadi ke Amrit Mahotsav, Chatkare Zindagi ke, etc were also organized by the theme.



1. Project Intervention

YP Programme and Internship

15 Young Professionals joined JEEViKA on 21st September 2021 and participated in a four-day induction program in Patna. Then they participated in a village immersion program at Rajgir block for 8 days. After their immersion, they were evaluated based on their presentation and were provided posting. The Summer Internship of 12 interns was completed in September 2021.



2. Competency enhancement Program

Exposure Visit cum training on moderation function of jeevika mobile vaani

Content Moderation is a crucial process that ensures the quality, quantity and flow of items contributed by the community members over the IVR mobile platform. To capacitate Manager Communication on moderation, two batches of training cum exposure program was organized at Ranchi, in which 16 participants participated and learned about the process of moderation and live moderation.

Workshop on JEEViKA Mobile Vaani- Technology Integration

A three days (29 Sept. to 1st Oct) workshop was organized with an objective to understand Mobile Vaani technology - IVR & Smart App interface, technology advancement features of JEEViKA Mobile Vaani and technology integration models for managing Mobile Vaani operations. Participants from MIS, M&E and Communication themes participated in this workshop.



Training on "Video Production and dissemination" by Digital Green

JEEViKA in collaboration with Digital Green conducted 3 days residential training program for Communication Managers & YP-KMC on "Community Video Production & Dissemination". The training program was customized depending upon the need of participants and contents of training included — camera handling, pre-production (research on issue, script-writing), production (understanding of equipment's like the use of camera, tripod, mic, diffuser & reflector), post-production (video editing tools), and process involved in video dissemination using Pico projector. After this training, Communication Managers and YP-KMC will act as a trainer in respective districts for community professionals and further train them on video production & dissemination.

3. Events

Independence Day Tableau



On the occasion of 75th Independence Day, JEEViKA participated in the Independence Day celebration organized at Gandhi Maidan, Patna, and presented a tableau displaying the Jal Jeevan Hariyali programme of Bihar Government. The tableau tried to replicate the ambitious multi-stakeholder programme which aims at climate sustenance, conservation and rejuvenation of water bodies to keep water pollution-free, maintain the level of groundwater, ensure adequate water availability, climate-resilient agriculture, energy conservation etc. The tableau depicted JEEViKA's success in terms of the plantation, entrepreneurship opportunity by opening and maintenance of "Didi Ki Nursery", integrated farming initiatives like pisciculture and duck farming/Poultry, solar intervention as environment protection initiative etc. The portrayal of the tableau was recognized and bagged the second spot in the exhibition.

4. Campaigns

Vaccine service- Protection shield of health "vaccination Mahaabhiyan"

Bihar aims to inoculate six crore people in the state against Covid-19 by December 2021. JEEViKA in collaboration with the Health Department is assisting in the mobilization of the community at the vaccination center in rural Bihar. Till September 2021, around 82% of SHG members have been inoculated with 1st dose of the Covid-19 vaccine while 27% of SHG members have also taken 2nd dose. The focus is also to immunize SHG family members. To accomplish this task several initiatives like door-to-door



campaigns, rallies, information sharing through leaflet distribution, mobile van popularly called Tika Express worked dedicatedly for creating awareness on vaccination. Promotion and adoption of Covid-19 Appropriate behavior, awareness and demystifying the myth against vaccination were also on focus. COVID and vaccination-related awareness campaigns were carried out by JEEViKA didis and vaccination campaigns were held at the cluster level.

Atma Nirbhar Narishakti se Samvaad

Prime Minister Shri Narendra Modi inaugurated "Atma Nirbhar Narishakti se Samvaad" on 12th August 2021, and interacted with the Self Help Groups across India promoted under Deendayal Antyodaya Yojana-National Livelihoods Mission (DAY-NRLM). During the event Honourable Prime



Minister lauded the <u>Self-Help Groups</u> for their unprecedented services during the Covid-19 period, like SHG women's unparallel contribution in masks making and sanitizers, providing food to the needy and spreading awareness regarding COVID protocols and preventions. In this samvaad program, more than 75 Lakh SHG members from 38 districts watched the program through live telecast on TV and webcasting. The event was live telecasted at 39 NIC centers of state and district. The program was telecasted and webcast at 9,97,764 locations at Village organization offices, Cluster Level Federation offices, Training and learning centers, Villages, panchayats and block offices and 50,000 households.

SHG members from different SRLMs also shared their experiences and success stories from different livelihood sectors. This provided immense motivation to SHG members to strengthen their existing livelihood opportunities or take up new livelihood activities.

Chatkare Zindagi Ke – A creative way of learning and growing

With an intent towards Social and Behaviour Change Champaign through digital mode, JEEViKA in collaboration with PCI International has developed a series of 3 audio-visual episodes called Chatkare Zindagi Ke and plans to develop in total 17 episodes. This series has been tailored to the local context of Bihar, especially for JEEViKA didis. The series contains messages related to health & nutrition appropriate choices and needs. Several topics like the involvement of male members in livelihood activities, linking of health & nutrition with livelihood, the importance of breastfeeding, complementary feeding, maternal diet diversity, the importance of nutri-garden, identification and management of disease, ante-natal care & birth preparedness, new-born care, family planning, and sanitation, etc. have been portrayed in the form of a story so that maximum number of JEEViKA didis can be made aware on required habits and procedures.

The series also focuses on gender sensitization and can be watched with family to break the taboos of gender-specific roles and responsibilities. Initially, "Chatkare Zindagi Ke" is being piloted in 10 districts with 2 village organizations in each district. After completion of pilot, these episodes will be disseminated in all the blocks using Pico-Projector.

Azadi ke Amrit Mahotav

Azadi ka Amrit Mahotsav is an initiative of the Government of India to celebrate 75 years of progressive Independent India and the glorious history of its people, culture, and achievements. The official journey of "Azadi ka Amrit Mahotsav" commenced on 12th March 2021 and will continue till 15th August 2023. This Mahotsav is dedicated to the people of India who have not only been instrumental in bringing India thus far in its evolutionary journey but also hold within them the power and potential to enable. Under this Champaign number of events are being organized at different levels and parts of the organization. A few of the events organized under this regime are workshops with Bankers and RBI for making our didis more bankable, facilitating distribution among the SHG and VO as ICF and RF, opening and operating of more RRS and DKR across Bihar, youth mobilization and Job fair at district level etc.

5. Publications and Media

Publications & Media- During this quarter, Knowledge Management and Communication team has published 3 Newsletters- Issue numbers- 50,51 and 52.

JEEViKA's community newsletter- To capture stories of women and CBO's the Communication team has published 3 Newsletters- Issue no. 12,13 and 14. The community newsletter is meant for distribution in CBO's and making community members aware of JEEViKA didi's exceptional performance. The stories are read out in the CBO's motivating other members and encouraging them to take up activities in their areas.

Satat Jeevikoparjan Yojna Monthly Newsletter- From this quarter, the project started the publication of SJY Monthly Newsletter. During this quarter, 1st and 2nd editions were published and circulated. The Newsletter is trying to show several aspects of ultra-poor families, the role of gradual approaches in their life cycle etc.

B. Monitoring, Evaluation and Learning

Process Monitoring by the third party under BTDP

Process Monitoring of the project interventions was undertaken in 19 BTDP districts by M/s Academy of Management Studies, Lucknow. Regular process monitoring with regard to functioning of 619 SHGs, 307 VOs, and 53 CLFs was done during this quarter. Besides, process monitoring of SJY intervention and 753 households were covered. Around 120 BC points were covered under process monitoring of Alternate Banking intervention. 25 case studies of SJY beneficiary were documented. Findings of the process monitoring were shared with District and State level teams through presentations and reports.

Process Monitoring by the third party under NRETP

M/s Sambodhi Research and Communication Pvt. Ltd, Uttar Pradesh is undertaking Process Monitoring of different intervention in 19 NRETP districts. The agency undertook process monitoring of livelihood interventions.

C. Management Information System

1. Development of receipt and payment module for CLF data under Audit application

During this quarter, a new module related to CLF receipt and payment entry was added to AUDIT APPLICATION. Users will now be able to check available cash and bank balance. The fund-wise analysis can also be done through this module. The fund analysis report will be accessible to blocks, districts and state-level users and it can also be downloaded in pdf format. The entry work in this application is being done by CA users. This application can be seen through the link: -www.mis.brlps.in

2. Development of Transfer Posting Web Application in Asp.net

'Transfer Posting Web Application' was developed in Asp.net. This application has a signup page for creating a user through OTP. Users are allowed to fill at most four districts of their choice to apply for transfer. This application captures some basic information of users to validate the data. 3. Development of LSBA-Solid Liquid Waste Management (SLWM) Mobile App

A mobile app. has been developed for the LSBA theme, which is related to Solid Liquid Waste Management. The final version of this app. is being used by LSBA theme and has been rolled out in field successfully. Some incorporations were also done as per suggestions from the field staff/LSBA theme. 4. Development of Livelihood Survey Applications

Initially, Livelihood Survey Applications was developed as a module in Aadhar seeding application as a web page and which was used through mobile app. Now, it has been developed as two separate applications as web and mobile applications.

This application has two types of users:

- Admin
- Cadres (CM) block level.

Admin User: They can reset cadre's password and can view the progress status of the information captured by cadres.

Cadres (CM): They will log in mobile app. and capture different types of information related to their livelihood.

5. Development of CLF GIS Locator Mobile App

This Application is under the modification phase. The purpose of the app. is to digitize the basic details of CFLs and their VOs. App. users can capture the CLF and VO's Buildings geolocation, address and capturing building photos. It is an online application.

CLF GIS Locator Web App

In the web application, currently, a dashboard is developed. It displays the counting of the total number of CLF, total CLF whose data is captured, and total CLF whose information is pending. There is also a graph that displays district wise same information as a vertical bar in the graph. 6. Development of JEEViKA Honey Application

Beekeeping is a traditionally well-established household activity and also an important source of income for villagers in Bihar. Altogether, 197 Beekeeping PGs are being run by members of

JEEViKA across 22 districts of Bihar. Main objective for developing this app. is to bring all members of JEEViKA PGs (beekeeping) at one platform where the project can get their production or output data for further marketing. Through this app, we can give various information regarding production of honey and also where PG members provide or sell quality product. This app. will also provide information of members' income through this intervention. The user can login to mobile application for capturing collection and selling information. Development of Grievance Redress and Monitoring System (GRMS)

- In GRMS, databases and tables were designed and created. The application is made functional for the following modules. In this application, DPCU level users can do actions like pending, reject, forward and close.
- SPMU level users can do actions like Pending, Reject, Close and Report.

9. Development of CEO Dashboard

During this quarter, a login-based application has been devolved to capture and display the

new entries being done every day and also cumulative figure. This is login-based application and entries can be displayed and tracked for Bank Sakhi tracking systems, community Professional's Payment Tracking System, JEEViKA Skills, Aadhar, E-Goatry, E-Poultry, SHG-HNS and CBO Audit.
