DPMs are requested to ensure service of office order to concerned transferred Community Coordinators and ensure its compliance.

Transfer allowance is applicable to all Community Coordinators except from Sl.No. 1 to 4. In the light of Chapter 5.1.1 of HRD Manual, one month's gross salary would be given in advance as transfer allowance, to cover all costs of relocation (including shifting the family, finding new accommodation, schooling of children, etc). This advance would be payable to the staff within a week.

The fact of above mentioned advance payment to the transferred employee must be mentioned in the LPC, issued from the present place of posting. After joining at transferred station, the official should submit transfer TA/DA claim within 7 days of their joining. The amount paid as advance would be adjusted from the bill.

This order is applicable with immediate effect.
