Rs-250/- (Two Hundred Fifty Only) per day will be paid by the Immersion Districts towards Immersion Allowance to compensate the Fooding/Lodging expenses during the Period.

All above Managers are relieved hereby on 01.08.2014 and are directed to report to their respective DPCUs by 9.30 A.M on 04th August, 2014 treating 02-08-14 & 03-08-14 as transit. DPMs are requested to send status of their reporting to SPMU.

After completing the Immersion, these employees will be reporting to their Place of Posting as proposed above against their names on 05th Nov, 2014 treating 03rd & 04th Nov, 14 as transit.

The Salary of these employees from their Date of Joining i.e 24-07-2014 onwards till immersion period will be paid by Immersion districts. SPMU will share the attendance of induction period with the immersion districts. LPC will be issued to these employees from the Immersion District before relieving for place of posting.

Managers on reporting to their place of posting would be allowed to avail hotel accommodation for one week (7 days) as per their entitlements from the date of reporting at their respective DPCUs. They are expected to arrange their accommodation within this period.

Travel expense for reporting to place of posting to these staff would be payable from their concerned place of posting as per rules.
