DPM in charge is also requested to send absentee statement to respective DPCUs. The salary of these employees would be payable from posting districts from date of joining at SPMU. DPM in charge of Samastipur is also requested to ensure release of payment of immersion expense @ 250 Rs/-Per day for the period of immersion up to 20 days as per actual/attendance.

They would be allowed to avail hotel accommodation for one week (7 days) as per entitlements from the date of reporting at their posting DPCUs. They are expected to arrange their accommodation within this period.
