Note:

1. This is the upper limit budget. All expenditure will be done and booked on actual basis.
2. During 7 days village immersion program (22nd to 28th Feb.) all fooding and lodging expense will be borne by the concerned BPIU. Maximum limit of per day food is Rs. 200/- per day and maximum limit of accommodation in village is Rs. 500/- for 7 days and payment would be directly given to House owner where he has been placed during village immersion.
3. During two months block posting in respective blocks the accommodation expenses will be borne by the staff and the DPCU will reimburse the TA/DA as per actual under HRD norms.
4. There is a provision for 10 days vehicle/month @ 1250/- per vehicle for 2 months.
5. Payment of the above mentioned managers would be paid from the concerned DPCU/BPIU.
6. The expenditure may be booked under BRLP-CID-Staff Training under 1.1.5.2.
