Transfer benefits as per HRD manual would be admissible. In light of Chapter 5.1.1 of HRD manual, one month's gross salary would be given in advance as transfer allowance to cover all cost of relocation. This advance would be payable to staff within a week.


The fact of above mentioned advance payment to the transferred employees must be mentioned in their LPC, issued from the present place of posting. After joining at transferred station, the official should submit the transfer TA/DA claim within seven days of their joining. The amount paid as an advance would be adjusted from the bill.

DPMs are requested to issue relieving order with direction to report at place of posting as above on 09th June, 14.

DPMs are also requested to issue LPC to the staff and a copy of this office order shall also be handed over to them.

The salary for the month of June would be payable from the respective district of posting. Salary would not be paid without receiving LPC from the previous district.
