Office Order

In continuation of Office Order issued vide Ref. No. BRLPS/Estt-HR/1101 /15 / 1199 dated 30.07.2015 in respect of deputation of BRLPS officers to CLF as CDM, it is further notified that the additional benefits/facilities have been approved to promote deployment of staff to CLFs as per detail given below:

- 1. The Cluster Development Managers (CDMs) would hence fourth be known as the Institution Development Managers (IDMs).
- 2. TA/DA norms would apply for moving out of the CLF area. However, Mobility Allowance within the area of CLF may be given slab wise as follows:

| Slab | No. of days of tour in a month | Amount |
|----------------------|--------------------------------|------------|
| 1 st Slab | 20 days and above | Rs.5000.00 |
| 2 nd Slab | 10 days to 19 days | Rs.3000.00 |
| 3 rd Slab | Less than 10 days | Nil |

For claiming the Mobility Allowance, tour programme for a month would be approved in advance by the DPM and after completion of tour, tour diary counter signed by the President of the CLF would have to be submitted to the respective DPCU.

- 3. Monthly salary would be payable from the respective DPCUs on the basis of absentee statements which will be self declared by the IDM but counter signed by the President of the CLF.
- 4. The IDMs would promote, nurture, strengthen and lead CLF to sustainable growth in accordance with project guidelines. A Facilitation Allowance @ Rs.8000/ per month would also be payable to IDMs deployed to CLF keeping in view of their nature of work.
- 5. Staff deployed to CLFs as IDMs, will move to their deployed locations and are expected to arrange their residences nearby respective CLFs. Hotel charges would be payable to newly deployed/posted IDMs equivalent to their entitlement for a week (seven days) from the date

of reporting to their respective CLF. They would have to arrange their residential arrangements within this period.

All thematic heads and DPMs are also requested to send names of experienced and suitable staff from AC and above positions who are having passion to work for development of CLFs at the earliest for deployment to CLF as IDMs.
