Office Order

It was reported by the DPM, Patna that Mr. Dharendra Mohan Yodhey, CC, Rangra Chawk, Bhagalpur, in association with 75 - 100 persons under the aegis of "Jeevika Karamchari Welfare Association" entered the Biscomaun office of DPCU and SPMU, Jeevika on 06.04.2015 and threatened officials of dire consequences if they did not vacate the office. He along with other accomplices mentioned above forcefully closed the office. It was reported that Mr. Dharendra Mohan Yodhey, CC, Rangra Chawk, Bhagalpur along with the said mob entered the DPM's chamber, abused him and dragged him from his office chamber. He switched off electricity and laptops, tampered with the laptop data and dislocated/ tampered the official files. It is also reported that personal mobile phone of DPM, Patna was also stolen during this period. Mr. Dharendra Mohan Yodhey, CC, Rangra Chawk, Bhagalpur also misbehaved with female staff and raised slogans against seniors. The above mentioned incident clearly indicates that he has violated Paras 13.1, 13.2, 13.8, 13.9 of BRLPS HRD Manual and thus committed grave misconduct as per Sl. No. - 8, 10, 12 and 15 of annexure 6 of the same.

The DPM Patna has also lodged an FIR against him.

He was issued show-cause notice and directed to reply explaining his position with regard to the above mentioned charges. Mr. Dharendra Mohan Yodhey, CC, Rangra Chawk, Bhagalpur submitted his explanation which was examined and it was found that he had failed to clarify himself with facts and evidences. Thus the charges are established. These charges are serious to warrant dismissal.

Therefore the services of Mr. Dharendra Mohan Yodhey, CC, Rangra Chawk, Bhagalpur with the BRLPS are terminated with immediate effect.
