OFFICE ORDER

With reference to the Memorandum of Cooperation between The Bihar Rural Livelihoods Promotion Society- BRLPS and The Project Concern International, India-PCI signed on 19th January,2015 with the purpose to provide Technical Assistance to Jeevika/ BRLPS to develop a strategy for integrating health and nutrition into Jeevika framework, it has been agreed to set up a dedicated state level team of technical experts to support the strategy development, project management, capacity building and measurement, learning and evaluation to support the implementation. The team will be embedded within Jeevika programme and report to the CEO while working in close coordination with the State Project Management teams within Jeevika to design and execute the health integration activities.

Presently, the following team members constitute the Jeevika Technical Support Team and their roles and responsibilities are defined as under:

Irina Sinha- Team Lead- Technical & Strategy Advocacy:

- Lead the process of strategizing, planning and coordination for programme implementation.
- Develop networks and linkages with stakeholders including relevant government departments, development partners and the community.
- Ensuring coordination and appropriate linkages on advocacy and policy work between Jeevika, World Bank, NLM, NHM, PCI etc.
- Coordinate with the technical team and develop policies, guidelines, toolkits for health and nutrition integration within Jeevika framework.
- Provide inputs to implement innovations and pilot projects.

Rajshree Das- Implementation Lead

- Lead the implementation support of interventions at the state, district and block level.
- Ensure quality assurance of programme implementation

Dr. Sudipto Mondal- CML Lead/ Santosh- Senior Manager, CML

- Generating evidence and documenting programme lessons for wider dissemination.

- Tracking of programme performance using defined set of indicators and periodic surveys.
- Interface with Jeevika M&E team.

Biraj Laxmi Sarangi- Technical Specialist- Nutrition

- Facilitate Institutional Capacity building on Health & Nutrition of Jeevika team.
- Pilot interventions on integrating health & nutrition within the Jeevika framework.
- Provide support in developing key messages on Health & Nutrition.

Sanjeev Jain-Technical Specialist- Convergence

- Establish convergence of Jeevika with the relevant department primarily Health, Social Welfare and Public Health and Engineering department
- Build capacity of the key staff at the state and district level on convergence and linkages
- Assist the implementation support team in implementation of convergence at block and below level.

The team above shall work in close coordination with the Jeevika team. More technical specialists may be engaged to achieve the programme objectives as and when required.
