### Office Order

A Complaint, dated 23/06/2015 was received from DPCU, Madhubani against Mr. Chandan Kumar Chaurasia, Community Coordinator, Madhepur wherein it was informed that on 22/06/15, a friend of Mr. Chaurasia tried to sexually assault a girl namely Ms. Nandini Rani in the room of Mr. Chaurasia, CC and Mr. Chaurasia stood guard outside the room where the incident took place.

In order to inquire into the matter, a committee was formed by the DPM, Madhubani.

The said committee inquired into the matter and on the basis of available facts, records and statements made by various stakeholders, the committee submitted its report.

According to the report of the committee, Mr. Chaurasia was involved in the offence. On the basis of the findings submitted by the committee a Show-cause notice, dated 15/09/2015 was issued to Mr. Chaurasia in order to provide him with an opportunity to defend himself. But, he did not choose to submit any reply/ representation in this regard inspite of lapse of more than one month from the date of issue of the show cause notice which shows that Mr. Chaurasia has nothing to say/ defend in this matter.

Thus, on the basis of the circumstances mentioned above, findings of the inquiry committee and recommendation of concerned District Project Manager, it is evident that Mr. Chandan Kumar Chaurasia is involved/accomplice in the incident. He has tarnished the image of the society and committed grave misconduct under Paras (b) 4, 10 and 15 of annexure 6 of the BRLPS HRD Manual. Accordingly as per the provisions, Mr. Chandan Kumar Chaurasia, is, hereby, terminated from the services of BRLPS with immediate effect.
