Office Order

It has been observed that advances given for various purposes including programme implementation as well as advances to CBOs are not adjusted in timely manner and outstanding advances are allowed to pile up which ultimately invite adverse observations from auditors and the funding agency. Simultaneously, the expenditure chargeable during the period / year are also reduced to that extent. In spite of repeated efforts from SPMU, the status of outstanding advances as maintained in SPMU is as follows:

- 2.
