DPMs of Purnia and Nalanda are requested to disburse salary for the month of January, 2015 to them from the date of joining at SPMU on the basis of absentee statement and relieve them on completion of induction/field immersion enabling them to report for duty to respective place of posting. They are allowed to avail transit time of two days from the date of relieving.

They would take over as DPMs from current DPMs/DPM-In Charge and work under overall guidance/control of SPMU including use of DOP.

They would be allowed to avail hotel accommodation for first seven days from the date of reporting to their place of posting as per their entitlement. They are expected to arrange their accommodation within this period.
