DPM Katihar is requested to relieve them on 23rd March, 15 with direction to report at place of posting as above by 26th March, 15 with two days transit (24th Mar -25th Mar, 15).

Rs-250/-(Two Hundred Fifty Only) per day will be paid by the Immersion Districts towards Immersion Allowance to compensate the Fooding/Lodging expense occurred during the Period.

BPMs on reporting to their place of posting would be allowed to avail hotel accommodation for one week (7 days) as per their entitlements from the date of reporting at their respective DPCUs. They are expected to arrange their accommodation within this period.

The Salary of these employees from their Date of Joining onwards will be paid from their Posting Districts. Immersion District is requested to share the attendance of these employees with posting districts.
