DPM Darbhanga is requested to relieve them on 28th March, 15 with direction to report at place of posting as above by 31st March, 15 with two days transit (29th Mar -30th Mar, 15).

Rs-250/- (Two Hundred Fifty Only) per day will be paid by the Immersion Districts towards Immersion Allowance to compensate the Fooding/Lodging expense occurred during the Period.

BPMs on reporting to their place of posting would be allowed to avail hotel accommodation for one week (7 days) as per their entitlements from the date of reporting at their respective DPCUs. They are expected to arrange their accommodation within this period.
