Office Order

It has been observed that there is prolonged delay in payment to community professionals in all districts. The office order issued regarding payment to community professionals (reference no. Timely payment to all community professionals needs to be essentially reviewed at BPIUs and DPCUs level on monthly basis with due diligence. The block wise compiled report against payment to community professionals (as per attached format) from all DPCUs duly signed by DPM/DPM-In charge should come to SPMU by 10th of every month. The payment status of community professionals of all DPCUs will also be reviewed in the State Meeting at SPMU. For FY: 2015-16 timely payment to community professionals will be considered as important performance indicator for all BPIUs and DPCUs.
