OFFICE ORDER

Financial irregularities came to notice of DPM, Nalanda against Mr. Rajesh Kumar Singh, BPM, Mrs. Prabhawati Kumari, Area Coordinator and Mrs. Poonam Kumari, Community Coordinator of BPIU, Ekangar Sarai, Nalanda.

A DPCU level committee was constituted to look into the complaint. The committee found Mr. Rajesh Kumar Singh, BPM, Ms. Prabhawati Kumari, AC and Ms. Poonam Kumari, CC, guilty of misappropriation of Community Funds and submitted its report accordingly.

An SPMU level Inquiry Committee was also constituted to look into the complaint. The SPMU level inquiry committee also found them guilty of misappropriation of Community Funds and submitted its report accordingly. Committee also found that Mr. Satyadeo, Office Assistant, Ms. Asha Kumari, Community Coordinator and Mr. Pankaj Kumar, BPM of BPIU Ekangarsarai have failed to maintain the financial discipline. Show cause notices were also served upon them from SPMU level to clear their position regarding the charges.

Reply to the show causes of Mr. Satyadeo, Office Assistant, Ms. Asha Kumari, Community Coordinator and Mr. Pankaj Kumar, present BPM of BPIU Ekangarsarai were examined and no fool proof evidence of their involvement in misappropriation of Community Funds knowingly was found. Nevertheless they could not prove their innocence above all doubts either.

Hence the competent authority has decided to award the following punishments to them:

- 1. Ms. Asha Kumari, CC: Her one increment is held up with cumulative effect.
- 2. Mr. Satyadev, OA: His one increment is held up with cumulative effect.
- 3. Mr. Pankaj Kumar, BPM to be served a note of caution to remain vigilant in future.

Ms. Asha Kumari, CC and Mr. Satyadev, OA to be served with warnings.
