Encouraged by implementation of PROHIBITION in the State through an enactment, SHG female member belonging to JEEVIKA, have planned their gatherings at different Divisional Headquarter to express their gratitude and solidarity towards this welcome development and also share to their experiences. As per the letter No. 318 dated 1.06.2016 of Principal Secretary, Cabinet Secretariat, Bihar, Patna, the programme at Patna Division has been finalized on 14th June 2016.

The Hon'ble Chief Minister has consented to be present in the gathering and address them.

The 14th June 2016 programme would be held at S.K. Memorial Hall, Patna where JEEVIKA Didi's from different district of Patna Divisiona would participate.

This programme of 14th June 2016 would also be web casted in concerned districts, where JEEVIKA Didi's would participate and they would watch CM's programme live.

For making hassle free & successful live streaming (Web Casting) at different location of Nalanda, Kaimur, Bhojpur, Buxar & Rohtas, following preparation & arrangement needs to be done under guidance of concerned District Magistrate.

- A. Selection of venue with seating capacity of 200 to 500 person.
- B. Selection and finalization of no. of Didi's from blocks for participation.
- C. Arrangement of vehicles (for their movement), snacks, water bottle and lunch for participating Didi's and staff.
- D. Flex / banner for backdrop at venue.
- E. Anchoring of programme by suitable person from JEEVIKA (preferably female).



- F. Arrangements of following items for live streaming / web casting.
 - i. 2 MBPS internet lease line.
 - ii. Computer system / laptop (i5, 04 GB RAM)
 - iii. LED screen / projector with screen.
 - iv. Sound system.
 - v. Manpower for handling above systems.
 - vi. Manpower of BSWAN should be utilized.

All concerned district would be given URL link for live streaming / web casting through BSWAN manpower on 13^{th} June 2016 and a trial would also be done on 13^{th} June 2016 from S.K. Memorial Hall, Patna.

It is worth mentioning here that success of prohibition is going to bring a landmark charge in social scenario of the State in general and rural women in particular. In this view, all concerned expected to extend their full support with utmost care and sincerity towards success of this programme.
