#### Office Order for SHAN Revolving Fund

The existing Health Risk Fund (HRF) has been restructured and set up as Sanitation Health and Nutrition - SHAN fund at VO level to provide financing support to SHG members for sanitation, health and nutrition related needs. The SHAN revolving fund is to be rolled out in 24 WASH pilot blocks covering 24 blocks (17 BRLP, 5 NRLM and 2 NRLP) of 10 different districts. As HRF has been restructured in SHAN Fund, so existing health saving will be continued as SHAN saving head in the VO across the state and VO may provide the sanitation and toilet construction loan to the SHG HHs. However provision of SHAN fund is Rs. 3 lakh per VO and this will be applicable in identified 24 WASH pilot blocks (BRLP/NRLP/NRLP) only. (The SHAN fund guideline is enclosed herewith & list of 24 WASH pilot blocks is enclosed in annexure -II.)

- Those VOs which have earlier received HRF amount of Rs. 50 thousand or Rs. 1 lakh will be topped up with remaining differential amount to match a total of maximum of Rs. 3 lakh, meaning thereby that differential amount will be given as second tranche of SHAN top up fund.
- Those VOs which has not received any HRF will be given a total amount of Rs. 3 lakh as SHAN Fund.

The SHAN fund will be disbursed based on the Open Defecation Elimination Plan (ODEP) or SHAN plan. The detail of business process has been mentioned in the SHAN fund guideline. The proper Books of Records need to be maintained at VO level by respective VO book keepers. (The format of ODEP/WASH plan has been enclosed in annexure -III and further SHAN plan format of VO will also be shared separately.)

The SHAN revolving fund will be disbursed by respective DPCUs under CIF head observing due procedure. However considering the urgent requirement and expedite the pace of WASH activities the SHAN fund may be transferred to listed 225 VOs immediately as approval has already been obtained from the CEO. The list of 225 VOs is enclosed in annexure – IV.

The DPM will form a team at district level to roll out the intervention in the identified blocks & GPs. The respective DPCU team will ensure intensive sensitization of staff and cadre to roll out WASH plan and ensure proper utilization of SHAN fund as well. SOP has been developed and enclosed in annexure – V. WASH CRPs will be developed and assigned for wash mobilization in the Gram Panchayat level to achieve ODF outcome in time bound manner.

#### Sanitation, Health And Nutrition (SHAN) Fund Guideline

#### 1. Introduction: Improving access to SHAN Financing:

Improved access to finance is one of the critical elements for achieving health, nutrition and sanitation outcomes. The BRLPS is looking for multiple ways to attain this by infusing Community Investment Funds by creating Sanitation Health and Nutrition (SHAN) fund at VO level and restructuring Health Risk Fund in SHAN revolving Fund. This note provides guidelines on SHAN revolving fund for financing sanitation, health and nutrition facilities, services and rural enterprises using community-based programs. The Jeevika sanitation, health & nutrition intervention includes awareness on linkages between health, nutrition & sanitation, triggering towards attaining behaviour change and demand generation for different services, facilities along with entrepreneurship development to sustain the intervention. Health Risk Fund (HRF) has been merged in SHAN fund. Health saving will be continued as SHAN saving fund. The total amount of SHAN fund is Rs. 3 lakh maximum subtracting of earlier given HRF amount to the respective VO. So the remaining differential amount is to be transferred as SHAN top up fund.

In many cases, the payment of government subsidies is considerably delayed hampering the progress and pace of the work. e.g. a time bound action plan for achieving Zero Open Defecation/Open Defecation Free status, the community institutions can provide bridge financing from SHAN fund to the **eligible member HHs** to help them make investments in WASH facilities in anticipation of the subsidy receipts under a recognized Government program. Enterprise financing can also be promoted in order to meet the material/ input needs for promoting sanitation, health and nutrition related activities in the community.

#### 2. Purpose and Objective of SHAN Fund

SHAN Fund is to set up dedicated financial arrangement to help poor households to improve their quality of life through access and usage of products and services. It will provide a suite of financing options that are appropriate, convenient and affordable including savings, loans and bridge financing options. These products, where necessary, are delivered in conjunction with grants and Government subsidies. Since major investments are required at both the supply side and demand side in the last mile, this fund will seek to extend financial assistance to households for making investments in creating and upgrading WASH facilities as well as health & nutrition related needs to achieve sustainable health, nutrition and sanitation outcomes.

### 3. Financing for Sanitation, Health & Nutrition facilities and services:

#### 3.1 Sanitation/WASH Financing:

Sanitation (WASH) financing entails supporting both long term investments as well as operational and maintenance expenditures towards construction, maintenance and upgradation of safe and accessible drinking water and sanitation facilities, besides promoting use of cleanliness and personal hygiene products.

Initially, investments are made to acquire a basic toilet. These are supplemented by maintenance and replacement expenditures. The basic toilets are subsequently upgraded by adding on suitable facilities and other aspirational features that enhance utility, convenience and comfort. Toilet upgradation is an

important investment, especially; if we are looking at the sanitation ladder where, the poor households intend to have opportunities to get finance for the new (upgraded) toilets. Financing avenues for waste disposal and its management enables households to address adequately the problems related with toilet waste.

#### 3.2. Health Financing:

Under the SHAN fund the Health financing is designed to help the poor to meet health shocks and expenditures like hospitalization, surgery, post-operative care, out of pocket expenses etc. by availing longer term loans from the SHAN fund. Under this arrangement, VO members are encouraged to save small amounts periodically into a common pool of health savings managed at the Village Organization (VO) level. Pooled savings can be used for giving small valued loans of short duration to meet emergency health expenses.

#### 3.3. Nutrition Financing:

Under the SHAN fund the Nutrition Financing will cover and promote locally available nutritious food items and promote available local entrepreneurs. The nutrition financing will provide the loan facility to the members for the purchasing food grain from the fair price shops or food available reasonable price in the market. This nutrition financing will give priority to women especially pregnant and lactating to avail loan for meeting nutritional and complementary food requirement at HHs level. The nutrition financing under SHAN will also complement the food and nutrition gap of existing FSF. Adding on to it, SHAN fund will also promote financing for nutri-garden, vegetable cultivation, eggs, milk and protein rich meat business.

#### 4. Components offered under SHAN Fund

Figure 1: Constituents of SHAN Revolving Fund

A. SHAN(HRF) Savings

•Health and Sanitation

B. SHAN loans and Bridge
Financing

•Sanitation(Toilet & sanitation facilities) Loans
•Health and Nutrition Loan

#### A. SHAN Savings:

The HRF saving is merged in SHAN saving and has broaden the purpose of saving for health, nutrition and sanitation. HRF saving is not a separate saving as it has been merged with SHAN saving. SHAN/HRF savings is a voluntary saving open to all members of the community institution for smoothing expenditures and investments in sanitation& health related expenditures and investments at the household level. As the size of the corpus of SHAN savings increases, supporting small investments towards repairs and improvements in WASH facilities may be considered. Unless a member is choosing to close the membership in the WASH savings account, the members can access these savings in the form of short tenure loans.

#### Features of SHAN Savings Product:

a. Amount of savings: The amount of savings may be decided by the community institutions based on the capacity of saving of very poor member of the SHG, in the beginning it may be around Rs. 5 - 10/- a month and further may be increased as decided by VO.

#### B. SHAN Loans

CBOs those have demonstrated good track record in SHAN saving will be eligible for availing SHAN loans of higher ticket size and with longer term duration. All VOs which have earlier been given HRF fund will provide the loan to their members for construction of toilet and other WASH related needs. The SHAN loans can be availed to make investments for acquisition of new WASH facilities or replacement and renovation of existing ones and all health purpose. All individual SHG members will be eligible for this SHAN loan; however VO will give preference to the ultra-poor and poor who are in utmost need of first financing. The SHAN loan would also include the Bridge Financing Loan. The very first month of the loan taken for construction of toilet will be considered as moratorium period and no interest will be charged for this month only. This bridge financing is done to promote the usage of fund as well as to promote the pace of toilet construction and its continuous usage. For remaining all other kind of SHAN loan will follow normal lending/ borrowing process and there will not be any moratorium period applicable on it.

#### Features of the SHAN loans are given bellows:

#### a. Eligible purposes for loan:

- Construction of improved toilets, shower rooms, water storage structures, hand washing stations, etc. or purchase and installation of water purification equipment, water filters etc.
- Meeting the subsidy part of the investment towards acquisition of approved WASH facilities
- Improvements like replacement of doors, roofing materials, sewerage connections, water pumps, electrical connections to toilets/bath, energy saving devices, lighting devices, etc.
- All Health purpose loan as per earlier provision of HRF would be covered under SHAN loan.
- **b.** Size of the loan: The size of the SHAN loan will largely depend upon the purpose and size of the investment and based on availability of the fund at VO level. However, for the initial period the maximum loan amount may be restricted to Rs. 12,000/- per household.

#### c. Repayment period for the loans:

- i. **SHAN Loan for Sanitation, Health and nutrition purpose:**-The SHAN loans may be repaid within a maximum period of 24 months.
- ii. SHAN loan for construction/renovation of toilet:- For the purpose of acquisition/construction of toilet construction the repayment period may be shorten and can be up to a maximum 6 months. Flexible repayment options are encouraged so that principal and/or interest portions may paid in weekly, fortnightly or monthly rests.
- d. Interest rates: prescribed rate of interest will be Rs. 1% per month.

#### 5. Management and Governance of SHAN Fund

Cluster Level Federation (CLFs) and VOs will put in place a dedicated governance architecture for WASH interventions by creating a Health, Nutrition & sanitation Sub-committee at VO level. Health Nutrition & Sanitation Sub Committees will be accountable for management and governance of WASH interventions, including SHAN Fund. The CBO fund flow system will be guided as per approved process fund flow system. The above all SHAN fund will be routed through CLF to VOs.


#### Financial Management mechanisms:

- a. Books of accounts (minutes, savings ledger and loan ledgers are minimum requirements) must be kept up to date along with the supporting documents.
- b. A trained bookkeeper would be placed and paid of incentive for the services rendered under corpus of CLF or SBM-G IEC head.
- c. Monitoring of books of accounts, utilization of loans and portfolio review should be carried out by the social audit committee of the CBOs on monthly basis.
- d. The accounts of the SHAN Fund should be audited on annual basis by auditor hired by Jeevika for audit of CBOs. Presenting the audit findings before the General Body of CBO is a good practice which needs to be followed.
