Office Order

A complain was lodged by the members of Kiran SHG that Mr. Kailash Kumar Mandal, Area Coordinator, BPIU – Dighalbank, Kishanganj during his tenure as AC in Kishanganj Sadar has illegally taken a sum of Rs. 5000/- from Kiran SHG in the state of hallucination. Based upon the complaint, the field movement of Mr. Kailash Kumar Mandal, AC was suspended vide order Ref. No. BRLPS/BPIU/Kishanganj Sadar/2014-15/016 Dated, 27.03.2015. The case was forwarded to the District Grievance Redressal Committee. The committee organised a meeting with VO and SHG members wherein it was reported that Mr. Kailash Kumar Mandal had returned the whole amount taken by him. Based on the report of Grievance Redressal Committee, his field movements were revoked and he was transferred from BPIU – Kishanganj to BPIU – Dighalbank where his work performance has been found good. Mr. Kailash Kumar Mandal has also apologised in written and ensured not to repeat such act in future.

Thus, he has committed grave misconduct as per Sl. No. (1) & (5) of Annexure 6 of HRD Manual of BRLPS. Hence, a penalty of forfeiture of one next annual increment with cumulative effect is being imposed upon Mr. Kailash Kumar Mandal, AC, Dighalbank, Kishanganj. He is also warned not to repeat such act in future otherwise stern disciplinary action will be taken against him.

Since, Kailash Kumar Mandal has also apologised and ensured not to repeat such act in future. Hence, taking a lenient view, the service contract of Mr. Kailash Kumar Mandal, Area coordinator, BPIU – Dighalbank, Kishanganj is being extended upto 31.12.2018.
