Office Order

It has been alleged that Mr. Manoj Kumar, Block Project Manager, BPIU - Saraiya, Muzaffarpur during his tunure as BPM, Majhaulia, West Champaran had fraudulently misutillized a fund of Rs. 1, 24, 995/-(one lakh twenty four thousand nine hundred ninety five) only in procurement of snacks on the occastion of celebrating International Womens Day by VOs. A District Level Inqurity Committee and subsequently State Level Inquiry Committee were consitituted to investigate into the matter. Post investigation, both committees asserted in its report that Mr. Manoj Kumar, the then BPM, Manjhaulia intentionally violated the instruction and guidelines issued from SPMU. Besides, No procurement guideline was followed by him. Moreover, procurement process was not minutised. The committee adjudged him guilty of instrumental in gross financial irregularity at block headed by him.

Therefore, a Show-Cause notice vide Ref. No. BRLPS/Acctt/382/14/2387 Dated. 04.11.2015 was served to Mr. Manoj kumar, BPM for furnishing explanation in the matter. Mr. Manoj kumar replied to the show-cause notice wherein he has denied all the charges levelled against him and tried to escape from the charges levelled against him.

On the basis of analyses of fact and record in the case along with the reply submitted by Mr. Manoj Kumar, it is evident that Mr. Manoj Kumar committed gross irregularities in procurement of Snacks and failed to follow the guidelines issued by SPMU.

Thus, Mr. Manoj Kumar, BPM has committed grave misconduct as per SI. No. (b) 1 & (b) 17 of Annexure 6 of HRD Manual of BRLPS. Hence, following panalties are being imposed upon him:

- 1. Forfeiture of one next increment with cumulative effect.
- Forfeiture / Recovery of performance incentive for the FY 2015-16.

Mr. Manoj Kumar, BPM, BPIU - Saraiya, Muzaffarpur is also warned not to repeat such act in future otherwise his services will be liable for termination from BRLPS.
