Office Order

There is proposal to provide Community Toilet and Water Filtration facilities for Mushahar households belonging to Village Bela Mushahari of *Subat* Panchayat under Saurbazar Block of Saharsa district. Around one thousand population of the village would be benefited.

The site measuring 2000 Sq. ft. for construction of such Community Toilets construction has been identified and the same has been purchased by an NGO named "Sanitation and Health Rights in India (SHRI) Foundation". Estimated cost of construction is ₹2,92,000/- (Rupees Two Lakh Ninety Two Thousand only) would be spent by SHRI Foundation and the rest of ₹10,00,00/- (Rupees Ten Lakh only) has to be parked by BRLPS with *Maa Janki* CLF of Saurbazar block. This amount would be under the head **NRLP-IBCB** budget line - "**B.2.2.3.5 Community Wash Academy**".

For effective supervision and control on timely construction of community toilet, an eight members committee consisting of 3 officials of Saharsa district (BPM-Surbazar, Manager-H&N and T.O.-Mr. Randhir), 3 members from Community would be nominated by *Maa Janki* CLF and 2 members would be nominated by SHRI Foundation.

Construction work would be done by some local vendor who would be duly hired by the above mentioned committee. Whatever expenditure is incurred would be processed, evaluated and monitored by the committee and accordingly payment would be made. Besides, SHRI would make expenditure on following item :-

Rest of the expenditure would be met from the amount parked by BRLPS with *Maa Janki* CLF. Procurement issue would be looked after by the Committee.

The Committee would also finalize tripartite draft of MoU which would be approved by CEO and agreed upon by the concerned three parties within 15 days.

The Community Toilets, after construction would be handed over to *Kanti VO* of Bela Mushahari for upkeep and maintenance. The Committee would be responsible for finalizing rates of the toilets construction related items and water filtration unit and also for recommending hiring of, and payment to vendor.
