Dear DPMs,


It has been observed that a number of districts are lagging behind in some of important indicators which are considered very crucial in running of project interventions. Till now, we have a huge gap in Revolving fund and VO – ICF disbursement, SHGs Profile validation and automation of profiles along with the saving and Bank Linkage account numbers and in the settlement of 6 months old advances especially MKSP. Along with the above indicators, the IHHL entry, payment and geo tagging in the intensive blocks to also need to be speed up.

The above mentioned indicators: - (1) Zero Gap in RF and SHGs Bank A/c opening, (2) Zero gap in ICF disbursement to VOs, (3) SHGs Profile, SHGs Saving A/c and Credit linkage A/c automation in MIS and (4) IHHL Entry, Geo tagging and Payment in Intensive blocks have to be reviewed on the daily basis by the districts and by the State team led by CEO, BRLPs on weekly basis.

The State has scheduled the Video Conferencing on the underneath dates to review the district performance based on the reports submitted by the districts on every Friday. The format has been attached as Annexure A.
