## OFFICE ORDER

BRLPS (Jeevika) has expanded its operations across all the blocks of the state. This has led to formation of large number of community institutions across the state. It is immensely important that community institutions are nurtured well and timely capitalization is ensured for all levels of community institutions.

Very recently all the district have been reviewed for their performance around capitalization. It has been decided that **all the DPCUs will be taking special drive to ensure that different components of CIF (RF, ICF, FSF and HRF) are given due attention and taken to next trajectory.** Adequate amount of fund availability has also been ensured to different districts. It will also be important to mention that **direction has been given by CEO, BRLPS to track the NPA of SHGs and also track substandard accounts that have the potential to turn into NPA.** Effective repayment to banks has to be maintained on continuous basis. Availability of vehicle is likely to aid the whole process of Capitalization, Repayment and work around Sanitation/Livelihoods.

Based on the above facts, approval has been accorded for the following aspects:

- Each of the districts with having upto 10 blocks has been allowed to hire additional vehicle upto 10 days over and above the present stipulated number in each month.
- Each of the districts with having blocks more than 10 in numbers (upto 15 blocks) has been allowed to hire vehicle upto 15 days over and above the present stipulated number of days in each month.
- Each of the districts with having blocks more than 15 in number has been allowed to hire vehicle upto 20 days over and above the present stipulated number of days in each month.
- Availability of vehicle needs to be leveraged for facilitating capitalization for all kinds of CIF (RF/ICF/HRF/FSF), follow up on repayment with banks and community institutions, nurturing community institutions for other quality indicators and sanitation.

e) **Role of Block Mentors need to be framed for integrating efforts related to above mentioned aspects of capitalization, repayment, sanitation and other related aspects.**

f) Each of the BPIUs with adequate number of interventions around community institutions also needs to be provided with additional number of days of vehicle support. **BPIUs with up to 10 panchayats** in number to be provided with **5 days of additional vehicle** over and above the present stipulated number of days in each month. **BPIUs with more than 10 panchayats to be provided with 8 days of additional vehicle** over and above the present stipulated number of days in each month.


g) This approval is applicable for period from **November 2018 to March 2019.**

h) Each of the DPCU and BPIU to ensure proper utilization of vehicle by converting targets into results.

i) It will be important to mention that vehicle needs to be utilized for facilitating preparation of documents related to saving account opening & credit linkage besides ensuring entry into MIS.

**Direction is being further reiterated to DPMs** about the responsibility that needs to be fixed on Block Mentors for follow up around repayment. **Direction is being reiterated for District Mentors** as well to facilitate supportive role around repayment. This will become important criteria of performance evaluation for FY 2018-19.
