Office Order

(To Facilitate the payment process of consultants working with FI theme at DPCUs and SPMU)

BRLPS(Jeevika) has expanded its operations across all the blocks of the state. This has resulted in formation of SHGs and their higher level federations in large numbers. The community institutions need to be capitalized timely both from the project and the mainstream financial institutions. In order to facilitate hand holding to the community institutions, project has laid down the structure of team at the state and district level (related to micro finance, micro insurance and community finance). This team is further complemented with the presence of consultants (both short term and need based) at state and district level. The services of such consultants have been taken after due approval of the competent authority.

Till now, SPMU was facilitating the process of payment of honorarium, TADA reimbursement based on the report submitted and the work done by them. It has been envisaged that process will be further laid down to ensure that payment of the consultants working at the district level is done from district only. Based on the above facts, following has been approved by the competent authority:

- a) Approval has been accorded for payment of honorarium, TADA (as per the stipulated norms) and communication allowance of Rs 1000/ per month to the consultants stationed at district level since January 2018. All payments till December 2017 will be made from SPMU only in order to avoid any confusion and to ensure smooth transition as well.
- b) The details of the consultant along with place of posting are being put on P59 to P67 on C-side. The indicated place of posting district will be ensuring payment of honorarium, TADA and communication allowance from respective district itself.
- c) SPMU shall be making reimbursement for the consultants whose place of posting is indicated at SPMU Level.
- d) Project has hired the services of people with experience to support the initiatives of the project on need basis. Their services have been instrumental in supporting

the project. It will be worthwhile to ensure their payment from the state as their services has been taken for different districts. The names of such people are Md. Naushad Alam, Mr. Dayanand Prasad Singh, Mr. Jairam Singh, Mr. Anuj Kumar Chand, Mr. Dharmendra Kumar Ojha, Mr Arun Kumar Sinha, Mr. Bagish Prasad Mishra and Mr. Umeshwar Singh.

- e) It is important to mention that in case designated consultants of district moves to other districts, He / She will be paid or eligible for fooding and lodging. This is made explicit that at this point of time the maximum limit for both lodging and fooding has been fixed at Rs 1500/ day. This includes expenditure of maximum of Rs400/ for fooding subject to submission of bills (Pucca bill or kaccha bill will suffice). In case when a person has exhausted Rs 400 in fooding, then maximum of Rs 1100/ (Rs. Eleven hundred only) can only be reimbursed for lodging arrangements (based on the original bill).
- f) Considering the need of frequent movement, all districts are advised to keep the budget of vehicle, honorarium, TADA, communication allowance etc. in the undergoing AAP. It is important and all the district are required to ensure the same.
- g) All the consultants have been shared with related TOR for each of the consultants. The same may be referred to in the future by related districts.
- h) DPM has been delegated with the responsibility to approve the payment to consultants with respect to honorarium, TADA and communication allowance along with other applicable expenses as per TOR.
- i) OSD/PC-FI has been delegated with responsibility to approve the tour and subsequently the claims made as well. At present, OSD is the approval authority.
 This is for SPMU stationed consultants.

The above mentioned endeavour will help in smooth transition and further movement for achieving of deliverables around Financial Inclusion (Document preparation, credit linkage, liasoning with banks, repayment, disbursement, insurance, audit, rotation, BCA model etc.)

Approval of the competent authority has been made for the compliance of the above mentioned aspects.
