## **OFFICE ORDER**

BRLPS( Jeevika) has kept an ambitious target of capitalization to the SHGs( both from the project and the mainstream financial institutions). This requires effort for providing training to the community cadres and staffs, distribution of documents, preparation of documents, liasoning with bankers, facilitating disbursement and ensuring followup for repayment. In the present circumstances, after the policy guideline has been laid out for insurance, it has become important and incumbent upon the project to scale up the work for providing risk mitigation to the households. The financial year is coming to a closure ( only 40 days are left) and thus it will be important to ensure facilitation on the above mentioned aspects.

In order to spurt the whole process in the present circumstances and for the work done in the past. Different DPCU have made request and sought some approval that can facilitate the whole process.

Based on the above facts, following aspects have been given approval.

- A. Saran (FI team) need to be provided with vehicle support for 15 days in the month of February and March 2018. This vehicle need to utilized specifically for the above mentioned aspects. However, as per the planning, other team collegues may also be joining for work to be done in different BPIUs. This will be over and above the stipulated budget of the DPCU to be booked under relevant heads.
- B. Supaul team has also submitted the request for vehicle support. Supaul has been allowed to hire vehicle for 15 days in the month of February and March 2018 to do the work as planned (with minor deviation as per the situation). The above mentioned clause applies to Supaul as well. This will also be over and above the stipulated budget of the DPCUto be booked under relevant head.
- C. PC-FI has been delegated with the responsibility to provide approval to different districts up to 15 days in the month of February and March 2018 based on the need and prudent justification. This will be over and above the stipulated budget.
- D. Approval of CEO, BRLPS has been accorded for utilization of vehicle by different DPCU on case to case basis. It has been observed that stipulated cost per day has increased due to distance. SPMU has been receiving request for approval of additional amount. PC-FI may be

delegated with responsibility to approve such small additions (primarily because of distance factor). This will apply for vehicle that has been used in the past & for vehicle that may be used in the month of February and March 2018.

The availability of vehicle is likely to give spurt to the whole endeavour of capitalization, insurance, Aadhar updation etc.
