Above mentioned Young Professionals will be allowed to avail hotel accommodation for 1 week (7 days) from 14-12-18. They are expected to arrange their accommodation within that period.

They will report to the respective DPMs/ Thematic heads.

SL no 35, Deepak Kumar will go for immersion in the posting district itself for a period of 13 days. After successful completion of immersion, he will be allowed to join against his posting in the district.

Sl no 11,27,29,33 will go on reimmersion from 14<sup>th</sup> December to 29<sup>th</sup> December 2018 in any block of the DPCU mentioned against their names. DPMs will be coordinating the immersion and reimmersion assignments of the above mentioned YPs.

For the YPs posted at SPMU, the respective thematic heads will ensure their immediate placement in DPCUs for a period of 3 months. Selection of the DPCUs will be made by the respective thematic heads based on the requirement of the theme. During these 3 months, the YPs will take up full responsibilities of the allotted theme and its indicators mentioned in the Annual Action Plan 2018-19.
