Slab Fixation and Annual Increment of DPCU and BPIU Staff (whose Slab Fixation and Annual Increment have been done till 2018) as per revised salary structure with effect from 01.09.2016 were communicated vide Office Order No. 2155 dated 13.09.18.

Some of the staff raised certain issues in respect of fixation of salary / Annual Increment. The issues were examined and accordingly has been rectified.

Following points have been considered in rectification:-

1. Salary fitment/Increment/Slab change is in continuation of previous fitment for each employee.
2. The data of fitment/increment has been prepared district wise.
3. Slab/increment has been fixed till year 31<sup>st</sup> December 2020.
4. Necessary rectification has been made in fixation of salary for those employees in whose case errors have occurred at the time of salary fixation in compliance to Office order no. 2851 dt. 29-09-16.
5. Due to disciplinary action, increment has been withheld in some cases with Cumulative or Non-Cumulative effect. Besides, due to Leave without Pay (LWP) shifting of date of increment has also been affected.

In view of above, arrears or recoverable may occur. Arrear payment to or recovery from concerned staff would be affected accordingly.

The scanned copies of approved Slab Fixation and Annual Increment documents are attached herewith for reference and necessary action.

DPMs are instructed to release/recover the payment to/from respective staffs as per attached documents at the earliest.
