Office Order

Plan & Budget for Livelihoods Farm Intervention (FY-2019-20)

Budget for the season of Kharif, Rabi and Zaid in FY-2019-20, the following Livelihoods Farm interventions have been planned.

- 1. The detailed Plan and budget district wise is placed in **Annexure-1**.
- 2. The payment of VRP/SEW/DG VRP/MRP will be done as per approved budget of FY-2019-20 mentioned in office order No. BRLPS/Proj –M & E /1511/19/600, Dated: 21.05.2019 for all 38 districts in respect of approved budget under cadre honorarium, the Budget Head may be referred as per **Annexure-II**.
- 3. The Training and capacity building of Cadres (VRPs/SEWs/DG-VRP/MRPs) and staff may be booked as per approved budget of FY-2019-20 mentioned in office order No. BRLPS/Proj –M & E /1511/19/600, Dated: 21.05.2019 following the cost norms as per office order BRLPS/Proj-IBCB/1042/16/3691, Dated: 15.12,17. The Budget Head may be referred as per **Annexure-II**.
- 4. Honorarium of VRP/SEW should be transferred in VO & CLF based on cadre indent in advance preceding quarter.
- 5. Every District will must ensure entry of farmer's data on regular basis in MIS. The DPM and the concerned BPM will be responsible for entry of farmer data.
- 6. The detailed budget and budget head for support in Video based extension system for video production, meeting cost for dissemination of audio visual extension system is mentioned in **annexure-IIIA** with detailed description of budget head in **Annexure IIIB**.
- 7. The detail budget along with budget head and budget description for organic farming is mentioned in **annexure IV, IVA, IVB** respectively.
- 8. The unit cost for Demonstration of innovative technology i.e Zero tillage, DSR, community nursery, mechanical transplantation, etc. is Rs. 4000/- per plot of 0.5 acres. The cost of demo plot will be routed through concerned VO.
- 9. In the area of organic cluster no inorganic fertilizers or pesticides will be promoted or sold by cadres, AEs or suppliers in any form. It will be the responsibility of DPM, BPM and Manger-LH to monitor the same in field.
- 10. Kitchen Garden will be treated as regular and universal farming intervention. CM/VRP will be incentivized as per the kitchen garden / the VRP policy for inclusion of HH under kitchen garden intervention.
- 11. BPM will ensure function of livelihoods subcommittee in VO and CLF positively. Livelihoods will be one of the prime agenda in every VO and CLF meeting. The BPM

- will review monthly to AC/CC on livelihoods interventions and send report to SPMU based on 10% physical verification of the field.
- 12. Old districts such as Nalanda, Muzaffarpur, Khagaria, Purnia, Madhubani, Gaya, Saharsa, Madhepura and Supaul where focus will be on livelihoods farm interventions. The team will ensure at least 30% household of CBOs must be covered under livelihoods farm activity along with other core activity as per project mandate to award CC, AC, BPM, DPM, Block Mentor and District Mentor as "A" Grade in performance appraisal. The team of rest districts at BPIU will only eligible for "A" Grade in performance appraisal after coverage of 20% of households in CBOs under Livelihoods farm interventions with other core activities. One year old VO may be taken for calculation of HH under the farm activity. This was already circulated through the office order No.... and has been effective from that date for calculation of performance appraisal for the concerned financial year and onward.
- 13. Where there is no VRP in VO, CM will support SHG members to handhold in Farm intervention and motivate farmers to adopt the technology. CM will get incentives of Rs 10 per farmer per month maximum upto Rs 500/- per month for the concerned VO. The expenditure of same may be booked under cadre Honorarium budget head.
- 14. Custom Hiring Center will be established in CLF under convergence with the Department of Agriculture. The CHC will be established as per the CHC policy office order No: BRLPS/Proj-LH/1172/17/3136 Dated: 04.11.17 and community procurement policy of BRLPS. Once the subsidy receives by the concerned CLF/VO that will be returned to DPCU against the advance under CHC fund and submit UC for the rest fund.
- 15. DPM, Manager-LH, LHS, Procurement Manager will ensure the availability of VRP register.
- 16. Block/ cluster level non residential training must be done at FTIC only. The effort should be made for hiring of training space of FTIC by external agencies (Government, Non-government agencies) as per FTIC policy. The concerned BPM will ensure training of all themes in FTIC as per FTIC policy. TLC if available may also be used.
- 17. The residential training of staffs and cadres should be included in District Training calendar with support of concerned thematic Manager.
- 18. Community appraisal of VRP and SEW will be on monthly basis to monitor agriculture interventions and facilitate timely payment of honorarium. Payment & appraisal will be made on the basis of monthly reporting Format. In Each 3 VOs there will be one VRP whatever be the number of farmer in VO/PG. The BPM will ensure timely payment of VRP & SEW, DG-VRP/MRP etc.
- 19. Each Cluster should have only one SEW whatever be the number of VRP in cluster. One additional SEW would be kept at FTIC/CHC for data entry and its day to day management. SEW payment will be done as per VRP & SEW policy.
- 20. The unit cost per Kisan Diwas is Rs 2500/-
- 21. BPM should ensure monthly review meeting of VRP & SEWs DG-VRPs at block level under his/her leadership.



- 22. Each BPM nominates one nodal person for livelihoods farm intervention among AC/CC at block level. Along with LHS, all ACs/CCs will be responsible for LH activity in their concerned field and all have to do Livelihoods work.
- 23. The inclusion of HH under farm intervention will be only considered after entry of data in farmer card and uploaded in MIS. The BPM will ensure the upload of the complete farmer card in MIS.
- 24. The DPM & Manager-LH/IC will be responsible to make available the farmer card to the concerned block and take review in the concerned monthly meeting.
- 25. The DPM will conduct the separate monthly district livelihoods review meeting with Manager-LH & BPIU staff send report to PM & SPM-Farm. By 10th of every month.
- 26. It will be the responsibility of DPM & Manager-LH to integrate complete farmer card and Livelihoods data in LH-MIS.
- 27. The Budget head and budget line for different livelihoods activity is placed as **Annexure-I** and **Annexure-II**.
- 28. This Plan & Budget of farm activity will be effective from 1st June -2019 to 31st May-2020.

Budget Description (Annexure-IIIB)

- ❖ Honorarium to Video Production resource Person (Rs-400 per person per Video, 3 persons for 3 days): This is for honorarium to be paid for video production team, who are engaged for video production. Amount of INR 400 per person per video will be paid and there will be total 3 persons will be engaged for 3 days for one video production.
- ❖ TA to Video Production resource Person (200 per person per Video, 3 persons for 3 days): This is for Travel allowance to be paid to video production persons. Amount of INR 200 per person per video will be paid and there will be total 3 persons will be engaged for 3 days for one video production.
- ♦ Honorarium to Dissemination resource Person @ 70 /-(Rs-50 for dissemination and Rs 20 for adoption): This is for honorarium to be paid to mediators per screening, who disseminate the videos at village. Therefore, for one screening, one dissemination form to be filled and for one dissemination form, amount of INR 70 to be paid. There will be INR 50 for dissemination and INR 20 for adoption.
- ❖ Monthly District level Review meeting (20 participants, 150 per person per meeting) for staff and cadres: This is for centralized monthly mediators/ cadres review meeting cost at district level. INR 150 per participants to be expensed for a non-residential meeting at district level. And, a total of maximum 20 participants will be participated.
- ❖ Quarterly BPIU Review meeting (Per block, 10 Participants, 5 Meetings, 150 per person per meeting): This is for quarterly mediators/ cadre's review meeting cost at BPIU level. INR 150 per participants to be expensed for a non-residential meeting at district level. And, a total of maximum 10 participants will be participated and total 5 meetings to be conducted during that period.
- ❖ Orientation to Project staff at district level (30 members, 1 day, 2 orientation) @ 150 Rs per person: This is for orientation/ training to Jeevika staffs at district level on the DG approaches and their engagements. There will be 2 such orientations, 1 day each orientation for 30 members max and INR 150 per participant's will be expensed.
- ❖ Training to Dissemination Resource Person (30 members, 2-day, 1 training @ 450 Rs per person): This is for training to video disseminators/mediators (VRP's/CM's) at district level on the Pico operation/handling and their roles & responsibilities. There will be 1 residential training for 2 day for 30 members and INR 450 per participants will be expensed.
- ❖ Printing of Dissemination & Adoption formats (30 forms per Pico, 14 months @ Rs 1 per form): This cost is for printing of dissemination & adoption form. As there will be 30 forms per Pico per month for 14 months and cost will be INR 1 per form.
- ❖ Internet Recharge (150 per month per district for 14 month): This cost is for internet recharge for Data Entry Operator for all kinds of farm related data entry. INR 150 per month per district will be expensed for 14 months.
- ❖ Repairing & Maintenance of PICO, Audio visual equipment's, camera, computer, etc. (Rs 1500 per month per district for 14 months): This is for repairing & maintenance cost of Pico, camera's speakers, computers and other related equipment's, that uses for video dissemination and data entry. INR 1500 per month per district for 14 months has budgeted.

1. CIF to Local groups For establishment & Demonstration

- Fund will be routed through the nodal village organization after submission of micro planning of organic farming by concerned local group.
- VO will forward the demand application of local groups along with members profile and micro plan to use the fund to concerned livelihood manager.
- Then livelihood manager will process the application at district level after proper scrutiny of the application.
- Fund may be used as per below table:-

2. Non-residential Training to Cadre & members of Local group.

- Training of Cadre of concerned CBOs where the members of local groups belong. Training will be given on organic farming, sustainable agriculture and ZBNF.
- BPIU will conduct this training in his/her block where district person will support in overall training.
- Livelihood manager to ensure the training in each block.

3. Residential training of Cadre at district level.

- Three days Residential training of cadre on organic farming will be organized at district level.
- Livelihood manager will organize this training at district level.

4. Residential training of Project Staff participants.

- Three days residential training of project staff on organic farming with one day full demonstration in field will be organized at district level.
- Livelihood manager will arrange this training at district level.



5. Review meeting of staff at District level for organic farming monthly.

- District level separate review meeting will be called on 10th of every month.
- Agenda of meeting will be on organic farming progress update and further action plan.
- Livelihood manager will call this meeting and will share the report with state till 15th of each month.

6. Development of purchase and sells center which includes seed bank and input material at block level.

- This Fund will be parked at CLF level to develop one stop shop for organic input facilitation as well as sale and purchase counter of organic produce of LG members. There will be one shop in each block near to market run by any VRP/LG member who will act as entrepreneur and formulate organic inputs and do the activity of sale and purchase of organic produce from his/her counter.
- This one stop shop will also be developed as seed bank where all kind of indigenous variety seed, improved variety high yielding seeds will be kept for promotion. No hybrid seed will be sold from this counter.

7. Promotion of organic products at district level.

• This fund is for promotion of Organic produce by local group in terms of promotion in different outlets at district level on all important places and government offices, printing of banners, flex, one pager, handouts, advertisement on electronic and print media etc.

8. Exposure of staff/cadre/farmers within State.

- An exposure cum training program can be arranged by livelihood manager/DPM as per requirement of district.
- Team can plan to visit within any district of states where they see better progress in the field of organic farming.

9. Honorarium to organic cluster coordinator.

- Organic cluster coordinator (OCC) will be new type of cadre for organic intervention in block.
- Organic cluster coordinator will look after two local groups and will be paid Rs.5000 as monthly honorarium and Rs.2000 as monthly communication & travel allowance.
- Recruitment of Organic cluster coordinator will be done through CLF in consultation with BPM and Manager-LH and their progress review and payment will also be made from concerned CLF.
- Organic cluster coordinator will be selected as per the below guidelines:-
 - Minimum education will intermediate
 - Experience in farming or worked as VRP/SEW in Jeevika.
 - He should be resident of intervened village where at least one local groups exists.
 - Cadre Selection procedure norms will be followed in the selection of OCC.
 - District livelihood manager will be the nodal person to be in the overall process of selection of OCC.

10. Organizing or participating in Kisan fair.

 To promote and sell of organic products, livelihood manager will facilitate to local groups members to use different platforms where they can have sell counter for their produce.
 Platforms like Kisan fair my line department, Event organize by CLF/Producer company/DPCU/BPIU/Job fair etc. can be used. A team should be formed by livelihood manager comprising of project staff and few cadre to be self-sufficient to organize/participate in the platform on a short notice.

11. Printing of IEC material/wall painting/leaflet / formats/ BOR/ Registers etc.

- Printing of IEC material related to organic farming practices will be done at district level and later will be distributed in each Local groups.
- Wall painting in related intervened village needs to done through BPIU.
- BORs to be designed and printed as per the norms of Participatory guarantee system of local group through BPIU/DPCU.

12. MIS executive at district level

- One separate MIS operator will be placed either at district or at block level.
- He will be assigned work allotted by livelihood manager.
- He will be the trained on PGS online registration of farmers and other application related to PGS guidelines.
- He will be provided with desktop and internet connection to punch all PGS related entries on time.

13. Vehicle at district level to visit in Organic project block/local group.

- A provision of vehicle at district level is kept to move in the block where local groups and organic project is ongoing of support and monitoring
- Vehicle will be hired under the budget of Rs.7500 per month.
