### OFFICE ORDER

SPMU has received requests related to project for approval from DPCU Siwan and DPCU Buxar. This includes aspects related to expenditure made during Mega Credit Camp and utilization of fund. Based on the facts mentioned, approval has been accorded for the following aspects:


(a) **DPCU, Siwan** has conducted a Mega Credit Camp on 31<sup>st</sup> August 2019. Post facto approval has been given for an amount of Rs 1, 22,500/- (Rs. One Lakh Twenty Two Thousand and Five Hundred only) towards the organization of the credit camp. Around sanction of Rs 21 Crore had been done. The approved amount of Rs 1, 22, 500/- is subject to actual expenditure. The district is required to follow the laid down stipulations for the expenditure.

(b) **Buxar district** is completely covered under BTDP project since 01.10.2016 (1<sup>st</sup> October, 2016). During FY 2017-18, an amount of Rs 3,30,00,000/- (Rupees Three Crores and Thirty Lakhs only) was received under NRLM fund for the purpose of payment of enhanced ICF to SHGs against the required amount of Rs 4,34,85,000/- (Rs Four Crore Thirty Four Lakhs and Eighty Five Thousand only). **The amount of Rs 1, 04, 85,000/- (Rs One Crore Four Lakhs and Eighty Five Thousand only) was spent out of BTDP fund for which approval was accorded by CEO, BRILPS for adjustment subsequently.** In the meantime, DPCU Buxar again received the amount of Rs 80, 85, 000.00 (Rupees Eighty Lakhs and Eighty Five Thousand only) dated 07.10.2017 as NRLM fund. This amount of Rs 80, 85,000/- remained as bank balance in the BTDP account. Subsequently During FY 2018-19, this amount was utilized for providing Revolving Fund to SHGs. Thus the NRLM fund was used to provide RF to SHGs. However, the expenditure was

booked under BTDP as the Buxar was BTDP district and RF to be funded out of BTDP fund only. Approval has been accorded for settlement of the advance amount appearing to BTDP through appropriate accounting treatment. Related authorities have been directed to book the expenditures accordingly and settle the accounts following Accounting Principles.
