OFFICE ORDER


SPMU of BRLPS has received some requests with respect to different aspects related to expenditure made/ expenditure proposed/ other administrative approval for different programs related to official purpose. All the related aspects were important for the result achievement on different parameters.

Based on the above facts, following has been approved:

- A) Approval has been given for an amount of Rs 1, 92,000 (Rs One Lakh Ninety Two Thousand only) for the program proposed with Central Bank of India. This approval is for DPCU Muzaffarpur. Around 10,000 SHGs had been credit linked with an amount of Rs 125 crores. This is for the period of December 2018 to February 2019. All the arrangements had been made keeping in view the visit of the CMD of CBI. However, the visit of CMD of CBI had been postponed. The date of the camp was on 26th February 2019.
- B) Approval has been given for an amount of Rs 83,000 (Rs Eighty Three Thousand only) to DPCU Samastipur for organizing credit linkage camp with SBI on 26th February 2019. Around 750 SHGs had been credit linked and GM-SBI was likely to be present in the program.
- C) Post facto approval has been given for the utilization of vehicle by MF-consultant of Madhubani in the month of October and November 2018 for 9 days and 12 days respectively. The distances travelled in both the months are 839 KMs and 1167 KMs. The payment has to be made based on the existing structure with DPCU, Madhubani. This means that hiring cost and fuel charges has to be paid along with applicable taxes for the mentioned months. The dates of the visit had been 16th, 22nd, 23rd, 24th, 25th, 26th, 29th, 30th and 31st October 2018. Similarly, the visits made in the month of November had been on 1st, 2nd, 3rd, 5th, 6th, 15th, 16th, 17th, 19th, 21st, 22nd and 23rd November 2018.

- D) Post facto approval has been given for an amount of Rs 95,075 (Rs Ninety Five Thousand and Seventy Five only) to Muzaffarpur DPCU towards facilitating the interaction of community members along with Joint Secretary Madam from NRLM. The visit and exposure was conducted successfully. The amount is as per the mail given by DPM, Muzaffarpur dated 25th February 2019.
- E) Approval has been given for an amount of Rs 52,000 (Rs Fifty Two Thousand only) to DPCU Arwal for organizing credit camp in consultation with the district administration. The date was on 26th February 2019. However, the date is likely to be shifted as well. This is not a standalone program of Jeevika. This will be integrated with the loan fair organised by district administration. As per the mail of DPM Arwal, honourable Deputy CM is also likely to grace the occasion.
- F) Approval has been given for an amount of Rs 76,880 (Rs 38,440 each for Mokama and Barh) for facilitation in the organization of program on direction of district administration. Honourable CM is also likely to grace the occasion. This is for DPCU Patna.
- G) One of the bigger blocks of Patna namely Paliganj needs due support and hand holding by providing a full fledged Block Project Manger (BPM). Approval has been given on the proposal of DPM, Patna to make Mr. Chandan kumar as the BPM of Paliganj. At present, Mr. Chandan is working as BPM, Belchhi. Mr. Sanjay Kumar Mishra, the existing Area Coordinator of BPIU Belchhi be made the BPM Incharge. This has to be implemented with immediate effect. Due process of handing over charge has to be completed.
- H) The tenure of the monthly hired vehicle of DPCU Patna has expired on 31st January 2019. The district team has followed the procurement through GeM and offline mode but has not met with success within the stipulated budget of Rs 18,000 per month (without fuel charges). At present, the DPCU is working by hiring on daily basis which is costlier. DPCU has requested for hiring of the vehicle **with budget of Rs 21,250/ month** (without fuel charges) as in the case of SPMU. Patna is a bit costlier and thus agency (Vandana travels) has offered to provide services at the rate of Rs 21,250 per month without fuel charges (the charge that is being given by SPMU). Approval has been given for hiring the vehicle with stipulated cost of Rs 21,250 per month without fuel charges and applicable taxes. This is allowed for the next six months. At the same time, DPCU has been permitted to hire vehicle through

procurement method upto an amount of Rs 21,250 per month (without fuel charges and applicable taxes).

This will be applicable for the existing procurement process undertaken and if the costs exceeds then fresh procurement to be done. However, in order to complete the day to day functions in district like Patna, DPCU Patna is allowed to hire vehicle from Vandana travels (agency hired by Jeevika-SPMU on the cost on which it is providing vehicle to SPMU).

This is based on the fact that BRLPS (Jeevika) has done due diligence for identification of agency for providing services.

The endeavour will help in fast tracking the work done by different DPCUs/BPIUs.
