In order to organize the four day residential training of Social Audit VRPs in above mentioned 23 districts following approvals are given:

1. Sixty batches training of Social Audit VRPs across 23 districts as per the approved budget of Rs.110000/- per batch (Rs.537 per person per day including lodging, food charges, course material, venue charges & group photo and Rs.1000/- guest lecture and Rs.23000/- for travel allowance, incidental charges & two day field visit).
2. The expenditure of the trainings to be booked under SHG-Social Audit VRP Training-SAS under separate component.
3. Twenty-three experienced social audit VRPs to facilitate/support the training to be organized in other than their own respective district. Their payment will be reimbursed by the Social Audit Society as per the letter no.411389 dated 12.02.2019.
