Office Order

According to the PG policy circulated vide memo No. BRLPS/Proj/473/13/4114 dt.02.11.2013, each PG was required to be provided a financial support upto maximum limit of Rs.6,10,000/- . As per the latest PG-PC policy circulated vide memo No. BRLPS/Proj./732/14/3551 dt.06.12.2017, it was made clear that except for produce aggregation all other activities have to be performed by the FPC.

The following provisions would be applicable in the concerned districts:-

1	The fund available in any PG in NRLM districts should be transferred to the parent FPC for better
	fiduciary and statutory management of fund. Any PG will access the fund through FPC as per the
	business plan submitted in the light of the PG-PC policy (2017).
2	Any PG in NRLM districts can access additional fund support through FPC based on business plan
	@ 12 % interest per annum.
3	Assets purchased for PG in NRLM districts as per the previous PG policy (2013) lying in the
	concerned PG, even if PG is not functional, assets should be transferred to the concerned CLF with
	the entry in assets register at CLF level immediately. No PG would run office with support from
	the project fund.
4	The Internal Auditor of the concerned district will conduct internal audit of FPC in the district on
	quarterly basis and send report to the DPCU & SPMU. This should be conveyed to the internal
	Auditor.
5	Presently some of FPCs functional in the NRLM districts are also supporting in the input supply
	and marketing to the SHG members of the adjoining BTDP districts (e.g Bhagalpur being
	supported by Khagaria, Patna being supported by Nalanda, Sitamarhi being supported by
	Muzaffarpur and Katihar being supported by Purnia). Therefore, financial support should be given
	to FPCs in NRLM districts from BTDP fund in the light of the approved PG-PC policy (2017) to
	maintain the uniformity in the project area.
5	Auditor. Presently some of FPCs functional in the NRLM districts are also supporting in the input suppl and marketing to the SHG members of the adjoining BTDP districts (e.g Bhagalpur being supported by Khagaria, Patna being supported by Nalanda, Sitamarhi being supported by Muzaffarpur and Katihar being supported by Purnia). Therefore, financial support should be given to FPCs in NRLM districts from BTDP fund in the light of the approved PG-PC policy (2017) to
