Office Order

BRLPS (Jeevika) has been entrusted with the responsibility of implementing DDU-GKY (Deen Dayal Upadhyaya Grameen Kaushalya Yojana) by MoRD, Gol. DDU-GKY has the mandate to provide young people with required skills on different sectors to aid the process of employability with the mainstream institutions. It has been envisaged that 148500 number of youths will be provided with training on skills over a period of 3 years starting from FY 2019-20 and ensure employability to at least 70% with mainstream institutions. This will help in enhancing income at the household level.

BRLPS (Jeevika) has awarded projects to different partners (also known as PIAs, i.e, Project Implementing Agencies) with responsibility to provide training to youths. At present, 65 PIAs are providing their services as Phase II and Phase III PIAs. The number of PIAs will increase over a period of time to cater to the requirement of training more number of youths to meet the aspirations of the economy. Due systems have been laid out to monitor the activities related to different PIAs. The process of monitoring is being aided by both DPCU and SPMU. The instrumental role is being played by different persons (Manager-Jobs/DPMs/SPMs notified as Nodal persons) at both DPCU and SPMU level.

In order to further strengthen the monitoring process of the PIAs, related persons are required to work on the following aspects:

a) Manager-Jobs in supervision of the notified nodal person from SPMU for different PIA is required to visit the centre for verification of the candidates and ratify the dossier maintained by PIAs. The related team is required to ensure that formats related to dossier verification are duly filled after proper visit to the centre on concurrent basis. The verification of Dossier and filling of the format need to be ensured within 20 days of the freezing of the batch. The format is enclosed as

Annexure-I. Nodal person for the related PIA from the state along with related Manager-Jobs shall be responsible for ensuring the same.

- b) It is mandatory to verify the attendance of trainees and trainers at centre on monthly basis. Similarly verification of the attendance for the trainees staying in the hostel premises also needs to be ensured on monthly basis. The responsibility for the same has to be shouldered by Manager-Jobs in supervision of notified Nodal person from SPMU for any PIA. The coordination has to be established with the Centre Manager of the PIA as well for the mentioned aspects. The formats for capturing the information after due verification is being enclosed as Annexure-II, III and IV.
- c) Auto generated attendance of trainees and trainers from AEBAS (Aadhar Enabled Biometric Attendance System) need to be verified. In case of failure of biometric machine/online attendance system, remarks will be added by related person based on evidence produced by PIA at the training centre. It is mandatory for the PIA to inform through email about failure of device/internet connection in case manual attendance recording is done. The information has to be shared officially to Nodal person of the PIA from SRLM with copy to Manager Jobs. Manager Jobs/In-charge Manager under supervision of Nodal person shall verify the manual attendance with CCTV footage before endorsing the same (manual attendance). In case CCTV footage/group picture of the day is not available then the attendance shall be treated as null and void.
- d) The entire verification report shall be kept in file by PIA at the Centre. Similarly the copy of entire verification report needs to be kept at district office of JEEViKA as well.
- e) It is mandatory for the PIA to submit **Batch completion certificate** (SF6.3A7) to Nodal Person within seven (7) days after completion of the batch.
- f) In case of Training Centre being located **outside the state**, the documents verification may be conducted by TSA/ SPMU team of SRLM or by Manager identified by SPMU on **Bi- Monthly/Quarterly basis**. Nodal person for the related PIA from the SPMU has to ensure the same.
- g) It has been observed that different formats are being used by PIAs to ratify participation of trainee identified as Family Member of SHGs. DDU-GKY stipulates that family members associated with SHGs promoted by SRLMs are eligible for training in different trades. For bringing uniformity across the state and more importantly.

An

integrating the work of DDU-GKY at the Block level, BRLPS (Jeevika) envisages adoption of format enclosed as Annexure-V. PIAs need to utilize the same format for candidate who has been identified as family member of SHG. All BPMs are required to support the endeavor of integration by ratifying the format and taking efforts towards mobilization of the candidates for different sectors.

h) PIA representatives also need to ensure that verification of the batches is done on timely basis in coordination with Nodal person from BRLPS (Jeevika).

i) Each of the PIAs has been allocated one Nodal person from SPMU. For further integration and efficiency, each of the nodal persons has been paired with Manager-Jobs/ in charge Manager-Jobs from different districts as team members. Manager-Jobs are required to fulfill all the tasks associated with their district and further support related Nodal persons in the accomplishment of the tasks mentioned in the scheduled office order. Manager-Jobs are required to work under the guidance of related Nodal persons. The details of the team members have been put as Annexure-VI.

All are directed to ensure that aspects mentioned in the letter are adhered in letter and spirit with immediate effect.
