## OFFICE ORDER

SPMU has received request from different DPCUs with respect to CIF. Based on the facts mentioned, approval has been accorded for the following aspects:


- Approval has been accorded for Additional ICF to 129 VOs across 06 blocks for the DPCU, Rohtas.
- Approval has been accorded for Additional ICF to 11 Vos across 02 blocks for the DPCU, Bhojpur.
- Approval has been accorded to DPCU, Purnea for providing Additional ICF to 67 VOs spread over 06 blocks.
- Approval has been accorded to DPCU, Sheikhpura for providing Additional ICF to 167 VOs spread across 05 blocks.
- Approval has been accorded to DPCU, Kaimur for providing Additional ICF to 197 VOs spread over 07 blocks.
- Approval has been accorded to DPCU, Arwal for making payment of Additional ICF to 140 VOs spread over 03 blocks.
- Approval has been accorded to DPCU, Supaul for making payment of Additional ICF to 163 VOs spread over 06 blocks.
- Approval has been accorded to DPCU, Bhagalpur for making payment of Additional ICF to 258 VOs spread over 07 blocks.
- Approval has been accorded to DPCU, Jamui for payment of Additional ICF to 79 VOs.
- All the above-mentioned cases from point A to point I pertain to the fact that the Additional ICF amount was supposed to be transferred till 31<sup>st</sup> March 2020. However, due to certain circumstances related to implementation, the scheduled amount could not be transferred within the stipulated time frame of March 2020 (31<sup>st</sup> March).
- DPCU, Saharsa has provided additional amount of Rs 75,00,000/- (Rupees Seventy Five Lakhs only) to 500 SHGs. The amount has been disbursed from 2 projects, namely BTDP (Rs 74, 57, 350.17/-) and NRLM (worth amount of Rs 42,649.83/-).
