Rural Retail Shop (Grameen Bazaar) program aims at improving accessibility of original, hygienic and quality products at profitable margin to Kirana shops run by JEEViKA promoted SHG women. The program is currently operational in 42 blocks of 13 districts.

The program is decided to be scaled up to each of the 534 blocks in FY 2021-22. To strengthen the program with market linkage for direct supply of goods at profitable margin, a common minimum scale of 100 Grameen Bazaar (Rural Retail Shop) is necessary to crack negotiations with big companies/Millers etc. Therefore, blueprint for expansion in February-March is prepared as detailed below: -
