OFFICE ORDER

Based on the work need of the SPMU and the request made by districts about some approval for carrying out responsibilities, following has been approved:


- a) Approval has been accorded for the continuation of the Help Desk Team at SPMU with the existing members. The members are Mr.Rajeev, Mr.Arvind, Mr Sant, Mr.Nand Lal and Mr. Shambhu. Mr. Nandlal will be operating from Buxar (his native place) during the COVID time. Buxar needed support as well to move to the next trajectory. The continuation of the Help Desk team will be valid for the FY 2021-22. Services of the "Help Desk Team" has been utilized to facilitate follow up on repayment and the follow up required on Interest Subvention in the FY 2020-21. Services of the "Help Desk Team" will be further utilized to cover other horizons within FI spectrum.
- b) In the FY 2020-21, work around CLF strengthening, higher doses of Credit linkage, Disbursement, Insurance, Timely Capitalization, Repayment, Interest Subvention, Dual Authentication and other works important for the project occupies pivotal priority. It will be immensely important that monitoring and facilitation of these activities are galvanized through the "Help Desk Strategy". PC-FI may be delegated with responsibility to identify up to 15 persons from across the district/ block to work with him on issue mentioned above. The person concerned may be placed at DPCU/ SPMU/ Place outside present place of posting to support the endeavor in better way. The above mentioned aspects will aid the process as PC-FI & SPM-BL have been provided with additional responsibility which required time and attention.
- c) Approval has been accorded for payment of an amount of Rs. 1,12,689/- (Rupees One Lakh Twelve Thousand Six Hundred and Eighty Nine only) towards the expenditure made on vehicle to complete the process of immersion for CC and AC at Patna. This is for DPCU, Patna.
- d) Approval has been given towards the expenditure made for opening of the Didi Ki Rasoi at RBI worth amount of Rs. 43,645/- (Rupees Forty Three Thousand Six Hundred Forty Five only).

- e) Approval has been accorded for the budget of Rs. 1, 10, 00/- (Rupees One Lakh and Ten Thousand only) for organizing credit camp in different blocks of Supaul. In addition to this, approval has been given for the expenditure of Rs 3495/- (Rupees Three Thousand Four Hundred Ninety Five only) towards use of vehicle. This is post facto approval. The approval is subject to actual expenditures.
- f) Approval has been accorded for the budget of Rs. 78,000/- (Rupees Seventy Eight Thousand only) for organizing credit camp at Sheikhpura. This is post facto approval. The approval is subject to actual expenditures.
- g) Considering repeated failure in procurement to hire vehicle at prescribed limit in Patna (due to higher cost), approval has been given to hire the monthly vehicle at the rate stipulated at SPMU. This will be applicable for period from 1st April 2021 to 30th September 2021. In between, DPM is directed to discuss the matter with procurement specialist and resolve the issue in congruence with district mentor.
- h) Post facto Approval has been accorded to DPCU Patna for an amount of Rs 8550/- (Rupees Eight Thousand Five Hundred and Fifty only) towards organizing the credit linkage camp at Naubatpur.

The above mentioned aspects will help in making the deliverable smooth on different aspects.
