The hon'ble Chief Minister of Bihar will address on the occasion of Prohibition Day on 26th November 2021.


DPM- Patna and Vaishali are hereby directed to involve Social Development Managers and Communication Managers for mobilizing and anchoring social campaign and for documentation of the such event. For making the programme successful, the concerned DPCUs are required to make the following preparations and arrangements in coordination with SPMU KMC & SD teams: -

- There should be representation of 200 SHGs members from Patna District and 50 SHGs members from Vaishali District at Gyan Bhawan, Patna at 09.30 AM
- DPMs should ensure that only those members who are physically fit are supposed to participate for the event.
- Each Community member participating in the event, should be provided with breakfast in the morning and 'Lunch Packs' both valuing approximately **Rs. 125/- per head** – including a one litre water bottle that should be distributed at a place away from the venue. **In no case the same would be distributed in or near the meeting venue.** The hygiene factor has to be maintained. The place where the packets are distributed and consumed must not be littered.
- All SHG members should wear proper mask and follow the COVID-19 appropriate norms at all times during the travel and at the Event.
- The concerned DPCU mentors should extend support to their concerned DPCUs for community participation.
- For safe to and fro transportation of SHG members, concerned DPMs are required to make adequate arrangements of vehicle as per actuals.

- The Vehicle arrangements and fooding cost would be booked under 'SHG Exposure head'.
- In Every Vehicle, two project staffs would be present to accompany the members to the venue. The project staff would be responsible for safe travel and ensuring proper seating of the members.

Note: - A Day before the scheduled programme, CEO, BRLPS will also review the preparation with Districts. Therefore, the concerned DPMS, Managers have to ensure their presentation in review meeting.
