Statutory Compliance: Non-Farm Interventions

Under Non-Farm Theme, community owned and managed business enterprises like Retail Rural Shop, Didi Ki Rasoi, Producer Company etc. are on an expansion spree and requires statutory compliance for effective functioning as business entity in the market sphere.

To strengthen the programs with statutory compliance, a Terms of Reference (ToR) has been outlined to avail services of professional resource persons like CA/Lawyer/etc. to meet statutory compliance needs of the programs. The District Unit is entrusted with the responsibility to streamline hiring of agency/individual as per annexed ToR to facilitate statutory compliance as required by various Non-Farm based programs.

All operational units of programs like Grameen Bazaar need to ensure adherence of applicable statutory compliance by April 2021 and upcoming units scheduled for opening from April onwards must fulfil the pre-condition of meeting statutory compliance before inauguration of the enterprise.

The services of selected resource may be used across the interventions in Non-Farm theme as per the applicable need of the enterprise. Expenditure on the same may be booked as per the budget head outlined in relevant guidelines some of which are listed below: -


