Office Order

Keeping in the view the need for a differential, intensive strategy for sustainable livelihood opportunity for Ultra Poor and highly venerable Households, Govt. of Bihar has approved the Satat Jeevikoparjan Yojana – covering over 1,00,000 ultra poor households through a customized ultra-poor graduation approach.

With the collaboration between CARE India & JEEViKA, a pilot intervention is proposed for detailed assessment on the health and nutrition status of **children in the age group of 6 – 9 months** in the SJY households of the identified villages. The implementation plan for the same will be developed based on the findings and in consultation with concerned partner.

Based on the assessment data, CARE India will facilitate health camps in collaboration with the Department of Health at different locations for basic health check-up of women and children. The health camps will also act as an instrument for ensuring linkages to health and ICDS services to women and children. CARE India will be training MRPs on Health, Nutrition, and Gender Based Violence (GBV) which will be another focus area of support with focus and the fact that the women of ultra-poor households are vulnerable to GBV.

- The pilot will be implemented in Districts— Gaya, Muzaffarpur, Nalanda and Samastipur after gathering information on the complementary feeding practices followed in the respective households.
- JEEViKA Village Organisations would execute this pilot in few identified pockets.
- Details of the pilot are envisaged in such a way that it reach out 50 villages in each District keeping in the view that there will be on average 10 children in the age group (6 9 months) in a given village.
- DPCUs- Gaya, Muzaffarpur, Nalanda and Samastipur are expected to provide necessary details of the geography, and households with children the above age group by 20th February 2021.

Based on the assessment data, the interventions will be implemented in 2 districts of Bihar. Later, these interventions may be scaled up.
