Note: All the trained participants have to impart the three days residential training to SJY eligible graduating households. The listing and detailing planning of eligible households for graduation training need to be done in consultation with technical partner Bandhan Konnagar team. The eligible households training plan must be shared with state team and its approval will be given by concern District Project Manager. The expenditure will be booked under NRLM/BTDP/NRETP capacity building component.

As per approval:

- As per plan, the training budget per participant (and also two additional resource person from Bandhan Konnagar) will be as per approved unit cost of TLC and in case of other locations, unit cost as per norms of residential training of community cadres would be applicable.
- 2. The participant may reach one day ahead in evening of the schedule training.
- 3. Projector and stationery at training must be ensured for the training sessions.
- 4. Additional Rs 100/- per person is also approved for printing, stationery, formats and learning materials for the scheduled training.
- 5. Actual TA of SJY MRPs for all the trainings will be payable from the respective BPIUs as per the approved SJY MRP Policy.
- 6. Covid-19 protocols should be essentially and strictly followed as per State and Central Govt. guidelines.
- 7. The expenditure of the trainings will be booked under NRLM/BTDP/NRETP.
