## Office Order

Now the time has came to send them related centre and facilitate next progression around the anticipated endeavor of opening a new center and strengthen the existing center at Gurugram.

## The other details are furnished below:

- a) Ms. Tanisha Verma has been allowed to join the BMRC Gurugram on dated 27<sup>th</sup> June 2022. She has been allowed to go to Gurugram on 26<sup>th</sup>/27<sup>th</sup> June 2022. She will remain at SPMU till 25<sup>th</sup> June 2022. 26<sup>th</sup> /27<sup>th</sup> June will be treated as journey in transit. She will work towards strengthening the working aspects at BMRC Gurugram.
- b) Ms. Shakshi Ranjana who is supposed to start BMRC at Bangalore has been allowed to travel to New Delhi for period from 26<sup>th</sup>/27<sup>th</sup> June 2022 to 3<sup>rd</sup> July 2022. She will learn the process of establishing the BMRC and the activities that are conducted there. After returning, she will continue till 25<sup>th</sup> July 2022 at SPMU.
- c) Ms. Shakshi Ranjana has been allowed to leave for Bangalore on 26<sup>th</sup>/27<sup>th</sup> July 2022 to establish the BMRC centre.
- d) They (Ms. Tanisha Verma & Ms. Shakshi Ranjana) have been allowed to get special allowance of Rs.10, 000/month as per office order no. BRLPS PROJ-JOBS/1925/21/4653 dated 30/12/2021. They have been allowed to get the Air ticket booked form the Organization for the mentioned journey.
- e) Ms. Tanisha Verma has been allowed for hotel accommodation within the prescribed limit for 7 days being a new place.
- f) Ms.Shakshi Ranjana has been allowed for 15 days of hotel accommodation within prescribed limit as it will take time to establish the center at Bengaluru.
