Office Order

In light of approval of EC (Executive Committee) of BRLPS in its 48th Executive Committee Meeting, the wages of the outsourced employees are to be increased on Annual Increment basis. As per the above approval of EC, if any new employee is hired through outsource s/he shall be given 05% increment as his/her 1st annual increment and in subsequent years s/he will get 10% increment in wages. Accordingly, the wages have been increased in previous years and will continue to increase till further order.
