Scaling Up of Integration of HN activities with 'Model CLF Strategy'

JEEVIKA in collaboration with PCI India, tested a pilot in 12 of the selected Model CLFs in 06 districts for **Integration of HN Activities in Model CLF**. This pilot was implemented from June 2021 to March 2022. Through this pilot, the M-CLF leaders including the SAC members were capacitated for conducting the performance review of the HN Cadre viz. CNRP and MRP and CBO's review to improve the quality of HN intervention in the M-CLF area. Independent research also suggests that the intervention was successful in transferring the programme ownership to the M-CLF and through CLF leaders' active involvement, the programme quality has improved.

The learnings and experience gained during the implementation of the Pilot is now being scaled up to 55 new Model CLFs. All the activities will also continue with convergence being at the core of the intervention at the previous 12 Model CLFs. The list of the Model CLFs is attached as annexure 1.

Implementation Design:

The intervention will have two sets of activities:

- A. For the Pilot Phase (12 Model CLFs)** – Capacity building on convergence and advocacy for optimal utilization of the Govt entitlements by the SHG households for selected schemes.
- B. For Scaling Up (another 55 Model CLFs)** – Capacity building for performance review of HN cadre viz. CNRP and MRP and VO's supervision aligned with the HN CBO MIS. It will also be followed by Capacity building on convergence and advocacy for optimal utilization of the Govt entitlements by the SHG households for selected schemes. (The detailed activity plan is attached as annexure 2)

VO Supervision by the SAC Members:

Based on the VO Grading after capsule – 2 training, SAC committee of the CLF will prioritize the poor-performing VOs and prepare a VO supervision plan and follow it. This feedback helps the RGB in conducting the need-based reviews and taking informed decisions.

The concerned BPM will be responsible for the monthly payment of the eligible expenditure to SAC members.

In the overall implementation of the project, CLF Coordinator will be the key facilitator to impart the trainings, provide mentorship and conduct review of the activities at the Model CLF level. S/he will also be responsible for the planning, coordination, and effective implementation under the guidance and supervision of the CLF Anchor and the concerned BPM.

PCI India will place One Innovation Coordinator in each of the districts to support the intervention. ICs will report to the concerned DPMs on day-to-day basis.

The overall responsibility to implement the intervention lies with the District Project Manager with the programmatic support team. Concerned DPMs will be responsible for the monthly submitting of the report on and before the 7th of every month. The monthly reporting template is attached as annexure 3. The DPM will review the pace and performance of the intervention on monthly basis for its effective implementation in the field.
