OFFICE ORDER

Vide Office Order No. BRLPS/Proj/639/14/1543 dated 06.07.2016 guideline for organisation of Animal Health & Awareness Camps (AH&AC) under JEEVIKA has been issued and vide Office Order No. BRLPS/Proj-LS/2698/26/533 dated 25.05.2026 revision of budget of Animal Health & Awareness Camps has been done.

With reference to the above-mentioned office order, advances are being provided to BPIUs for organizing Animal Health and Awareness Camps. However, following the implementation of the SNA-SPARSH system, there is no provision for payment of advance.

In light of the above concern, it is directed that as an alternate arrangement, the Cluster Level Federation (CLF) of the concerned block may also organise the Animal Health & Awareness Camp at the Panchayat/Village identified by the BPIU. The BPIU shall identify the Panchayat/Village for organising the camp based on the availability of a larger number of cattle and the potential for wider outreach and maximum coverage of livestock-owning households. The CLF shall organise the camp within the approved budget and in accordance with the provisions, norms and guidelines prescribed under Office Order No. BRLPS/Proj-LS/2698/26/533 dated 25.05.2026.

After successful completion of the camp, the CLF shall submit the actual expenditure bills, along with all requisite supporting documents, to the concerned DPCU for reimbursement. The DPCU shall verify the bills and supporting documents and, upon satisfactory verification, reimburse the expenditure to the CLF in accordance with the applicable provisions and approved budget.

All other provisions, norms, procedures and guidelines contained in Office Order No. BRLPS/Proj/639/14/1543 dated 06.07.2016 and Office Order No. BRLPS/Proj-LS/2698/26/533 dated 25.05.2026 shall remain unchanged and continue to be applicable.

This order shall come into force with immediate effect.

Note: In case, fund is available in concerned BPIU CID head, BPIU can also organise the camp as per the earlier issued guidelines mentioned.
