With reference to the letter (KS-NRO-E253/2020; dated 22.03.2023), we accept the request for the closure of existing MoU and will last by 31.03.2023. For the formal closure, NRO-KS team need to conduct a formal meeting to submit closure report on key deliverables (as per MoU) in the month of April, 2023.

In addition to this, with reference to the advisory MoRD, Gol (file no: J-11060/13/2015-RL-Part (1), dated 9th March, 2023} regarding closure of PRI-CBO convergence pilots (50 panchayats, 10 CLFs, 6 blocks, 3 districts) and transition to universal roll out strategy (112 CLFs, 34 blocks, 3 districts), NRO-KS team will conduct the scoping study (key stakeholders' analysis) by 15th April, 2023. The proposed scoping study will cover 3 blocks, 3 CLFs, 3 panchayats and 3 VOs along with selected households (members of SHGs) in 3 districts (Muzaffarpur, Patna, and Nalanda).

Subject: Regarding closure of PRI CBO convergence pilots and transition to universal roll out strategy.

Sir/Madam,

As you are aware, a decision was taken to develop a strategy for universal roll out PRI-CBO convergence instead of intensive pilots for the same in very limited geographies. The revised strategy has been developed based on the learnings from the convergence pilot projects and programmes implemented by other organisations.

It is, therefore, requested to wind up the ongoing PRI-CBO convergence pilot project activities by 31st March, 2023 and transit to universal rollout strategy from 1st April, '23 onwards. The concept note and implementation strategy was shared with states as part of AAP document and the same is attached herewith for your ready reference. It is suggested that all pilot project blocks be included into phase-1 of the implementation of the revised strategy.

In order to carry out smooth transition and initiate the universal roll out activities in the 1st quarter, the following preparatory activities need to be accomplished by end of April, '23:

- 1. Completion of Scoping Study by April 1st week
- Sharing of final list of districts and blocks for the implementation of universal rollout strategy with NMMU by 15th April, '23. These may include blocks with model CLFs on priority.
- Approval of MoU (draft shall be shared shortly) with NRO along with NRO budget (for initiating roll out in May, '23).
- Preparation of draft State Operational Framework (SOF) and State level consultation workshop with SIRD, DoPR and other local agencies (if any) by 25th April, '23
- Approved Cadre Policy for district level CRP (DRP) and GP level CRP (LRP) in place, CLF managers positioned
- 6. Signing of MoU and Finalising the action plan for 18 months
- 7. Hiring of agency for Baseline study (ToR to be shared shortly by NMMU).
