## Office Order

## Extension of MIS Executives/ Data Entry Operators

Vide Office order BRLPS/Proj-MIS/941/16/340 dated 07.05.2018, the MIS Executives/Data Entry Operators have been shifted to blocks for expediting the data entry work. The pace of digitization has improved in most of the districts and it can be improved further. In order to maintain the momentum of digitisation and to improve its pace, the approval is given on the following by the competent authority: -

- 03 (three)months extension has been given to MIS Executives/DEOs of 06 BRLP districts in order to hire the operators through CLFs in accordance with the office order BRLPS/Proj-MIS/854/15/776 dated 03.06.2019.
- 2. 06 (six) months extension i.e. up to 31.12.2019 is granted to DEOs on daily basis in the rest 32 districts.
- 3. 04 (four) additional Data Entry Operators can be hired in each district for a period of 03 months to clear the backlog of digitization which will end by 31<sup>st</sup> Oct 2019. DPMs have to make an assessment of the requirement keeping in view the magnitude of backlog and use them rationally in the blocks.
  - They have to intimate requirement of additional DEOs before engaging them, to the SPMU.
- 4. The provision of rent for desktop/laptop will remain the same as per the existing approval.
