Funding arrangement at Village Organization for Goat Intervention

To universalize the Goat Intervention across different districts of Bihar, it has been decided that implementation of Goat intervention would be carried out through Village Organizations (VOs) without formation of Goat Producer Group by Pashu Sakhi.

For the implementation of different activities related to Goat Intervention, in lieu of the previous funding arrangement at Goat Producer Group, funding at Nodal Village Organization has also been arranged.

Details of fund arrangement for each of the nodal V.O would be mentioned as below:

Triggers for providing above mentioned fund would be as follows:

- 1. VO should be at least 6 month old.
- 2. Placement of Pashu Sakhi at Nodal VO would be essential.
- 3. Pashu Sakhi should be trained on 1st Module related to the intervention.
- 4. Pashu Sakhi should have surveyed at least 100 Goat rearing Households of the same or the concerned areas.

The concerned AC/CC will facilitate Village Organization in preparation of fund requisition in the light of the above mentioned triggers after discussion in the VO meeting. Fund requisition with supportive documents will be submitted to DPCU with recommendation of the concerned BPM. Manager/YP/In-charge Livestock after examining the requisition would further send the same to finance section after approval of DPM for fund disbursement.

AC/CC to validate refill of Medicines and other supporting items in Pashu Kit on quarterly basis and ensure proper recording of transactional records related to Goat Intervention in the VO books of record. BPM, along with Manager-Community Finance will support and examine related books of record on regular basis.
