Office Order

Vide Office Order BRLPS/Proj-MIS/941/16/340 dated 07.05.2018, the operators at district level had been shifted to blocks and data entry from block level was initiated from 01st June 18. It had to be ensured that each Block has one MIS executive/DEO (on daily wages) and It was expected that the pace of data entry would improve as the number of operators has increased and the delay in sharing the data to district has been also eliminated. Still the outcome during the four months is not satisfactory.

It is very important and critical to have updated MIS in the organization for better monitoring. Accordingly, it is directed that the digitization related to following be as per indicated timeline:-
