## (OFFICE ORDER)

Considering the need of the community, BRLPS (Jeevika) has taken decision to provide additional amount of Rs. 10000/- (Rs. Ten Thousand only) to each of the SHGs that have been provided with ICF (Initial Capitalisation Fund) between 1<sup>st</sup> July 2015 and 31<sup>st</sup> December 2016. The same has been communicated to the districts through office order numbered BRLPS/Proj – FI/497/14/Vol.– V/1731 dated 3<sup>rd</sup> August 2019 (03.08.19).

The letter stipulated that the above mentioned additional amount of Rs. 10000/- (Rupees Ten Thousand only) to each eligible SHGs as ICF amount need to be transferred/provided till 31<sup>st</sup> August 2019. **It was supposed to be transferred through Public Financial Management System (PFMS).** The time extension was provided to all the districts to ensure transfer of fund to all the eligible SHGs till 30<sup>th</sup> September 2019. The extension in time frame till 30<sup>th</sup> September 2019 was communicated through the office order numbered BRLPS/Proj–FI/497/14/Vol–V/2156 dated 4<sup>th</sup> September 2019 (04.09.2019). As the whole process is required to be done through PFMS mechanism only, there is a felt need to extend the time so that the scheduled activity can be completed fully. Based on the above mentioned facts and the request received from some of the districts, approval for the following has been accorded:

- a) The time stipulated for transfer of additional ICF amount of Rs. 10000/- (Rupees Ten Thousand only) to each SHGs that received ICF amount between 1<sup>st</sup> July 2015 and 31<sup>st</sup> December 2016 has been extended till 31<sup>st</sup> October 2019. At present, the time stipulation had been till 30<sup>th</sup> September 2019.
- b) This order also includes the approval for those DPCUs that provided additional ICF amount to the eligible SHGs after 30<sup>th</sup> September 2019. Related DPMs are directed to ensure that only eligible SHGs have received the additional ICF amount of Rs 10, 000/- (Rupees Ten Thousand only).
- c) DPCU Sitamarhi has been made an assessment that 4738 SHGs are eligible for additional ICF amount. 4649 SHGs are having the same savings account and thus it can be transferred straight into their account through PFMS system. However, 89

SHGs changed their banks and thus their Savings Account number has changed. Approval has been accorded for the transfer of additional ICF amount to 89 SHGs in their updated savings account. DPM and related BPM are directed to ensure proper recording of the facts both at BPIU level and DPCU level.

- d) **DPCU Madhubani** has shared the list of **51 SHGs** whose accounts have been shifted from C.B.I/Allahabad Bank to SBI, Ghoghardiha. Approval has been accorded for DPCU Madhubani to transfer the additional amount to the new accounts of SHGs maintained at SBI, Ghoghardiha. Both DPM and BPM are directed to ensure proper recording of the facts both at BPIU level and DPCU level.
- e) DPCU Samastipur had been given approval to disburse ICF to SHGs in February 2017 (The district was supported to disburse ICF to such SHGs till 31<sup>st</sup> December, 2016). There were altogether 1608 such SHGs whose approval was given for disbursement within 07 days of the approval accorded on 04<sup>th</sup> February 2017. The approval was accorded because of the absence of DPM Samastipur between 25<sup>th</sup> December 2016 to 31<sup>st</sup> December 2016. There is a need to consider disbursement of additional ICF to all such 1608 SHGs. Approval has been accorded for disbursement of additional ICF to identified 1608 SHGs with an amount of Rs 10,000/- (Ten Thousand only) to each such eligible SHGs. The stipulations mentioned as per the office order numbered BRLPS/Proj-FI/497/14/Vol-V/1731 dated 03<sup>rd</sup> August 2019 (03.08.2019) will apply. The only exception is approval extended in the month of February 2017 for 1608 SHGs.
- f) It is reiterated and made explicit that all ICF amount (in this case additional ICF amount) will be transferred through Public Finance Management System (PFMs) only.
- g) DPCUs and BPIUs are directed to ensure that funds are transferred to only SHGs that are eligible as per the office order numbered BRLPS/Proj FI/497/14/Vol. V/1731 dated 3<sup>rd</sup> August 2019 (03.08.19).
